It actually did recover them. Another interesting program that Steve Bass of PC World just recommended is WhoLockMe. Steve says, “Have you ever tried to delete a file or a folder, only to get a Windows error message saying you can’t do it? The reason may be your fault — the file, or a file within a folder, may be opened by a program. But I’ve had a folder that’s empty that I just couldn’t get rid of it.

WhoLockMe Explorer Extension is a handy little tool that shows what process is locking a file or folder. It lets you kill the process — a virus, trojan, or spyware, or in my case, a dialog box enhancer — in order to delete stubborn file/folder.”

2. The consignment table operates on a 90/10% basis — with the owner getting 90%, and the Club treasury 10%.

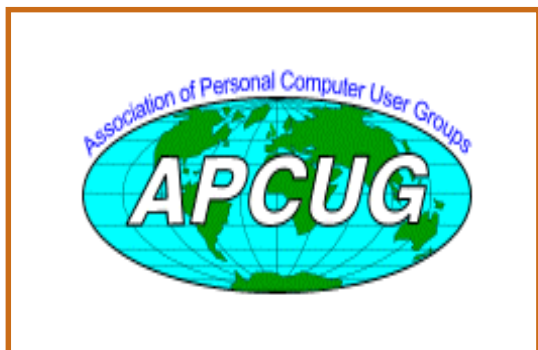
3. Fill out a tag on each item! It must contain: Seller's Name, NOCCC Membership Number, Item name, a short description and selling price.

Dual-Core Processors Are Coming!

Both Intel and Advance Micro Devices (AMD) are screaming, "Dual-Core Processors are Coming". They say they are the future of microprocessors for computers. With both companies planning to introduce these processors in the next few months it is important to understand the significance of this development.

So what is a dual core processor? Basically it is two microprocessors on the same integrated circuit or chip. Having more than one processor in a computer has been around for a long time. It is normal for servers to have them. Multiprocessor workstations (high end desktops) are used mostly for scientific, engineering and digital content creation for TV and movies. Dual core is not Intel's hyperthreading that is on its Pentium 4s, which lets the operating system think it has two processors rather than one. In a dual-core processor there are two actual processors, each one having its own L1 & L2 caches.

Why are we going to dual-core processors? One of the main reasons is heat. The higher a processor's clock speed, the more heat it produces. The 3.6 GHz Pentium 4 did have heat problems. Of course what we have been doing is just put more than one processor on a motherboard to increase performance beyond what you can get with a single processor (The general rule has been that adding a second processor improves computer speed by 60% over a single processor of the same speed). However, to make this more cost effective, similar, use less space, and reduce power requirements putting two processors together on one chip is better. This is especially true in the desktop and notebook markets. As we move to high-definition TV resolution video on computers the need for the average computer to have very high processing speed will appear, leading to dual-core processor computers being dominant a few years from now. But can you upgrade your current system to a dual-core processor? If you have an AMD socket 939 motherboard you can upgrade to an AMD Athlon 64 dual-core processor with only a BIOS upgrade. The same is true for AMD Opteron socket 940 motherboards for Opteron dual-core processors. Intel said last fall that some Intel LGA 775 motherboards would be able to use their dual-core processors, called "Pentium D", but they now say the first generation of them will have to use a modified LGA 775 socket. This of course means getting a new motherboard.

For an application program to take advantage of a

multiprocessor system, both the operating system and the particular application you are running have to have the ability to use more than one processor (multi-threaded program). If the operating system is able to take advantage of more than one processor, but the applications you are running are not; you may get different applications running on different processors, but each will only use one processor. Windows 98 and ME are designed for only one processor, so they can only use one processor even though there are two processors on one chip, real or virtual. Windows XP Home can use only one processor chip, but up to two processors on that chip. Windows XP Professional is designed to use up to 2 processor chips and up to 2 processors on each chip. Novell's SUSE Linux is already ready for dual core processors, and Red Hat Linux soon will be. Both are multithreaded and multiprocessor chip operating systems.

Most current multithreaded application programs are mid-high end scientific, engineering, CAD/CAM and digital content creation programs. This includes video editing and 2D and 3D animation and image creation/editing programs. However there are some home applications that already have this multi-treading capability, such as the Adobe Premiere Elements video-editing program. The first programs for the home user to go multithreading should be content creation/editing, multimedia, and games. There seems to be an expectation by Intel that the transition over to most programs being multithreaded 3 years from now. However, some software companies base the licensing fees of some or all of their programs by the number of processors using the program. The question then becomes will software companies start charging licensing fees per processor core that the current per processor chip? Right now it looks like the trend says no. Microsoft has already said for its programs that are licensed on a per processor basis it will remain doing so and not go to a per processor core basis. Also to consider in upgrading both Intel and AMD systems you may have software you have to activate that logs the system components. Upgrading processors and motherboards can cause these programs to say that this is now a new computer you are running the program on, which you are not authorized to do, and refuse to run. This could include your operating system. Check with your program's publisher/manufacturer to see what their policy is on this is (home and office use policies effectively have been known to be different).

So when will these marvelous dual-core processors appear? For Intel it will be the second quarter of 2005. For AMD it will be mid-2005 for the high level Opterons and second half of 2005 for the desktop Athlon 64s. As normal the price should originally be high, but then drop significantly over time.

We are moving this year to dual core processors. They



will improve the speed of computers, and reduce the related heat and power requirement issues. They will be originally for those high-end power users, but over the next few years they could easily become the norm. They will be in a computer store near you later this year.

How a Media Center PC Works as a Family Organizational Tool

Editors Note: *the "Figures" that are referenced in this article were not available on the Mindshare Web Site. There are several good ideas in the article that can be used for other purposes. I think a Media Center PC has great potential but needs to be a computer that is dedicated to that task.*



If you have a Media Center PC, which runs Windows XP Media Center Edition, you already know how to have fun with media throughout your home. You probably use your Media Center to record, pause, and stop live TV; play CDs and stored music; create CDs and DVDs; and download and edit video from a DV camera. You may even play games on the Internet or on your local area network. After all, you purchased the Media Center to have fun, right?

But a Media Center PC is a lot more than the entertainment hub of your home. Sure, it's a PVR, stereo, movie editor, and media tool, but it's also a computer and a powerful one at that. I've been using my Media Center to help connect and organize family members for months now. I've read several posts in the Media Center and Outlook newsgroups from people wanting to do the same. Now that I've set up a shared calendar on the Media Center in my home, I don't know how we ever got along without it.

In this article, I'll cover how to set up a Media Center PC to organize your family activities with a shared calendar, task lists, and other items. I'll explain how to turn on Fast User Switching, set up a family Media Center account, and set Outlook and the shared calendar to open automatically when any family member logs on to that account. I'll also explain how to share the Outlook Calendar on your personal network by publishing it as a Web page. I'm assuming in the procedures that you have Windows XP Service Pack 2 (SP2) installed.

How to Share Family Information

I started by creating a Family account that anyone can log on to on our Media Center. If you're going to use a Media Center in this manner, make sure your Media Center PC is placed in a central location like your family room or living room and configured for all to use.

In the Family account I have a calendar, to-do list, wish list, grocery list, and shared folders filled with data, including spreadsheets of phone numbers and addresses, scanned class schedules, and ongoing grocery and hardware lists. It's the refrigerator, address book, and junk drawer all in one!

Because anyone can log on, everyone can add to the calendar and lists. Everyone in the family knows what's happening at any given moment. Other information is also available: doctor's names and numbers, lunch menus, and soccer game schedules and locations. I've even uploaded the calendar and other information to my family's personal Web site, so anyone in the family can access it from anywhere, anytime. I have to synchronize it a few times a week to keep the Web information up-to-date. Incorporating our Media Center into the family has really improved communication, and we're all much more organized.

Create the Family Account

Creating the family account takes a little more thought than just adding a new account named **Family**. There are a few more things to consider. First, you should turn on Fast User Switching, so the account can run in the background while others are logged on. Using this configuration, the account can be accessed quickly by anyone, even if someone else is using the computer.

You're not going to set up this account for e-mail, just sharing the calendar. Users will log on to their personal accounts to send and receive e-mail. Full shared-calendar functionality, where users can access and change calendar data, is only available when there is an Exchange Server (or third party software) on the network. For more information about Exchange Server, read the Exchange Server 2003 Product Overview.

Because the account will be running in the background, make sure you don't install and/or run unnecessary services and programs on that account. Refrain from using the account for anything other than its intended use—a family organization tool. If you leave the account running in the background when it's using unnecessary system resources, others who are logged on may notice a performance hit. To create the account and turn on Fast User Switching:

1. Click **Start**, click **Control Panel**, click **User Accounts**, and under Pick a Task, click **Create a New Account**.
2. In the Name the New Account window, under Type a Name for the New Account, type **Family**, and then click **Next**.
3. On the **Pick an Account Type** page, under **Pick an Account Type**, click **Computer Administrator**. After the account is set up and configured for sharing, you can change this to Limited if desired.
4. Click **Create Account**.
5. On the **Pick a Task** page, select **Change the Way Users Log On or Off**.
6. On the **Select Logon and Logoff Options** page, select both **Use the Welcome Screen** and **Use Fast User Switching**.
7. Click **Apply Options** and close the User Accounts window.

You should now click **Start**, click **Log Off**, click **Switch User**, and log on to the Family account to verify it has been created correctly.

You'll notice that no password is required to log on. You may want to change this behavior later if your computer is not physically secure or if anyone other than family members has access to it. Once logged on as an administrator, you can begin the configuration process.

Configure Outlook Calendar, Notes, and Tasks Lists

I use Microsoft Outlook 2003 as my personal information manager and communications program. I like its Calendar feature, Tasks list, and Notes, all of which are perfect for the job at hand. (I'll use Outlook as an example, but you can perform the same tasks with other calendar or organizational programs.)

To open Microsoft Outlook and configure it for your family's use, log on to the Family account and then follow these steps:

1. Click **Start**, point to **All Programs**, point to **Microsoft Office**, and then click **Microsoft Office Outlook 2003**. Wait while the program configures itself for first-time use on this account.
2. Click **Next** to start the **Outlook 2003 Startup Wizard**.
3. On the **E-Mail Accounts** page, click **No** when asked to create an e-mail account or connect to an Exchange server. Click **Finish**.
4. In Outlook, click the **Calendar** icon and a calendar page for the day opens. Figure 2 shows an example.

Note that you can also select the Tasks icon or the Notes icon to view and configure those items.

Configure Outlook and Family Folders to Open Automatically at Logon

You can configure the **Family** account so that when it is accessed after the initial startup, Microsoft Outlook and your organizational folders automatically open. This will allow those folders to be open all the time and easily accessible by members of the family who aren't computer-savvy. First make sure dragging and dropping is enabled for the Windows Start menu, by following these steps:

1. Right-click **Start**, and then click **Properties**.
2. In the **Taskbar and Start Menu Properties** dialog box, click the **Start Menu** tab.
3. Click **Customize**.
4. In the **Customize Start Menu** dialog box, click the **Advanced** tab, and then select the **Enable dragging and dropping** check box in the **Start menu items** list.

To set Outlook to open automatically the first time the Family account is accessed after start up:

1. Click **Start**, point to **All Programs**, point to **Microsoft Office**, and right-click and hold **Microsoft Office Outlook 2003**.
2. Drag the selection to the **Startup** folder (located in the **All Programs** menu).
3. Release the mouse button, and then click **Copy Here**.
4. The icon and selection for Microsoft Office Outlook 2003 will now be listed in the Startup folder.

From now on, every time the computer is restarted and a user

Science Fiction Nightmare

accesses the Family account for the first time after the restart, Outlook will start automatically. The user will not have to click Start, point to All Programs, and locate the program manually.

Besides having programs automatically start when the computer is started and the Family account is first accessed, you can also have any folder you've created open automatically too. To make this happen, perform the steps described above, except drag the **folder** you've created and want to add instead of the program. The folder may be located on the Desktop, in Windows Explorer, or inside another folder, but the process is the same:

- Right-click the folder, drag and hold over the **Start** menu, then the **All Programs** menu, and then drop it into the **Startup** folder.

You should also share the folder, so network users have access to it from their personal computers.

Configure the Family Calendar to Open First

When Outlook opens, it automatically opens to the e-mail Inbox. Because Outlook will not be used to send and receive e-mail on the Family account, and only the Calendar will be used, you can change Outlook's default behavior to open directly to the Calendar, saving you the trouble of clicking the Calendar icon. Here's how:

1. Open Outlook, and on the **Tools** menu, click **Options**.
2. On the **Other** tab, click **Advanced Options**.
3. Under **General Settings**, next to the **Startup in this folder** box, click **Browse**.
4. In the **Select Folder** dialog box, select the folder you want to appear when you start Microsoft Outlook. In this case, select **Calendar**.

Share with Others on Your Local Network

You can share your family's calendar on your own network, so it can be accessed by all network users from any networked computer. You can also share the folders you've created to store your important phone numbers, physicians names and address, the local pizza parlor, and similar data. As detailed above, you can configure these folders to automatically open at startup, just as you can with Outlook. To learn to share folders you've created, read [How to Share and Set Permissions for Folders and Files Using Windows XP](#). It's a pretty simple task, assuming your network is set up and running properly.

The easiest way to share Outlook's Calendar on your personal network is to publish it as a Web page. As with any Web page, you'll have to republish the information often so it's up to date, and users won't be able to make changes to it from the network.

To publish your calendar as a Web page by following these steps:

1. Open **Microsoft Office Outlook 2003**, and then open your family's calendar.
2. On the **File** menu, click **Save as Web Page**.
3. In the **Save as Web Page** dialog box, under **Duration**, configure the **Start date** and **End date**. Configure other preferences, including a background graphic, if desired.
4. Under **Save As**, click **Browse**, and browse to the location

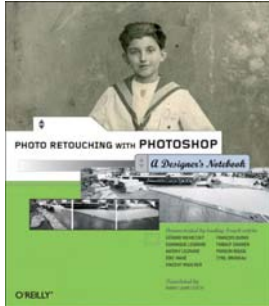

Photo Retouching with Photoshop: A Designer's Notebook

This is the third of a four-book series being produced this year by the publisher: O'Reilly ISBN: 0596008589, which list at \$24.95 each. They are four of a set of fourteen, written in French, presenting techniques of well-known French artists. This volume, written by Gerard Niemetzky, Domonique Legrand, Antonio Legrand, Eric Mahe, Vincent Risacher, Francois Quinio, Thibaut Grangier, Poisson Rouge, and Cyril Bruneau is translated by Marie-Laure CLEC'H. It is a 95 page soft bound of high quality paper and lavishly illustrated with at least 160 diagrams, pictures and Photoshop reproductions.



It is an eight project (called studios) collection, each demonstrating the artist's techniques from start to finish. Most used Photoshop CS with a Macintosh G4. All had professional photography equipment. To give a feel for the book's organization I will elaborate somewhat on the last studio "Aroma."

A high-powered French duo was hired by botanical beauty firm Yves Rocher to photograph and retouch shots of a new line of products. The presentation follows along as the shots are taken and the images are cleaned up and prepared for a print campaign. The final result is the first page shown. The final result is presented first in all studios. All studios follow with a three image film strip presentation, with supporting sketches depicting the transition of the work. A pretty good accounting of all that has to be done for this project is contained in a marked up photo. A sketch of the photographer's set up is shown. The light boxes used have plexiglass panels diffusing flash units which are behind them and the reflectors indicated there are several white cards which are used in a manner to obtain precise reflections in the liquids.

This project describes many things such as outlining using the pen tool, layering, combining photographs of the bottles which required different lighting/reflection. There was painting of the liquid colors over the back lettering, also the cloning out of spurious reflections, and a gradient laid over the reflections in the mirror, etc. The gradient went from white to transparent from the bottom to the base of the display between layers.

The other first seven studios present the following:

Image Restoring – An ancient photo was scanned and restored in its embossed frame.

Digital Surgery – An attractive model was made more attractive by hinging at the waist and patching back.. The overall included artificial skin, treatment of hair and color techniques.

Late Afternoon in Nosy Be – A scene of squalor in this island northwest of Madagascar was made appealing by manipulating brightness and adding a Las Vegas sky.

Beauty Institute – A four image array of the same colorized beauty was chromatically retouched.

Sails, Perspectives and Curves - A large camera panoramic of a sail-making workshop is stitched corrected and finished involving calibration.

Bloody Mallory – The techniques to create an eerie scene of an ancient church graveyard for Julien Tycoons film *Bloody Malloy* are explained.

Firefly – Here a surreal universe is created from a model posed crouched on a padded chair made to float on a created starry sky. Using colorimetry the surreal appears real.

This inexpensive book, written for professionals, is a useful addition to the library of any serious amateur photographer or digital illustrator. It contains many useful tips. ■

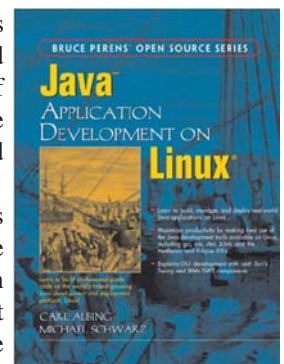
Java Application Development on Linux

The book's stated goal is to save developers trial and error in the selection of development tools and the methods of deploying and administering applications.

The authors' rationale is that many books describe how to program with Java on Linux, but that deployment and administration issues are largely ignored. They propose to create a simple business application and show the utility of isolating the business logic from its user interface, allowing them to build different "front ends," specifically Command Line, Swing GUI, and web pages created by (JSPs? Servlets?).

The authors' state that the book is for experienced programmers, not the Java beginner. Since it deals with free tools, it is also of limited use to someone with a multi-million-dollar budget who will want more powerful



commercial products, especially web servers.

This book does not have a CD-Rom; instead a companion website offers links to the tools used and the complete source code of the examples. The exercises were created using Red Hat Linux and Java 1.2.

The book has three foci:

- Readily available tools you need to develop and deploy software
- The Java technologies available to help you implement the software, and
- The architecture your business solutions should fit into

The tools include basic shell commands in Linux, the Sun and IBM Java JDKs, the make tool ANT, the code version control system CVS, the JUnit testing package, integrated environments like NetBeans and Eclipse, the web server programs JBoss and Geronimo, and the GNU Java Compiler gcj.

The Java technology includes information on the life cycle of various types of Java objects, the use of Remote Method Invocation, the JDBC database interface, Enterprise Java Beans, Servlets and Java Server Pages for providing application functionality along with JNDI for mapping names to objects, and the creation of JARs and EARs for deploying your code.

This is a tremendous amount of ground to cover. To the authors credit, they know they are offering an abbreviated reference on a given tool so they end each chapter with “What You Still Don’t Know” section, which has URLs and book recommendations.

The other problem this book has is that it can’t decide what level to write for. The stated audience is people with experience, which means that they don’t really need to include a primer on software design, and a sketchy one at that. I think it would have been better to drop the text on gathering requirements and analysis and design and go straight to separating a provided design into its persistence, business logic, and presentation components, which would have been more in keeping with the stated objective of the book.

In the end, I cannot recommend this book. Its main failing is trying to do too much, and it results in uneven quality at best and confusion at worst. For example, the database portion of the book tells you how to set up Postgres, but the JDBC book concerns itself with MySQL and Oracle. Perhaps the authors assume you can set up a MySQL database without instruction, which is a good bet - MySQL is indeed easy to set up. But, it will leave you wondering why you just went through the trouble of setting up Postgres.

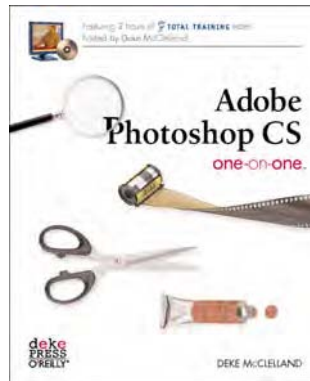

Adobe Photoshop CS One-on-One

Imagine you have a tool shed with thousands of tools, each one with its own set of accessories. Each time you have a job to do, it takes time and experience to decide which tools to use. That is what using Adobe Photoshop is like - and why there are so many books on how to use it. Adobe Photoshop CS One-on-One by Deke McClelland is one great book on how to use the tools provided by the latest version of the king of photograph editing software.



The book has 12 lessons, each of which covers several topics about Photoshop. Some of the topics are basic; using Photoshop’s file browser, correcting color balance and levels in an image. Other topics are much more complex such as creating and using masks and building composite images. Each lesson is accompanied by a video in QuickTime format which comes on an included CD-ROM.

I recommend following the installation procedure in the book precisely, starting with the preface. The video lessons are good in and of themselves, but are usually no longer than ten minutes, and cover only a fraction of the lessons in the book. Aside from some audio stuttering in a few places, the videos worked well. The only problem with the content is that the author, who narrates the videos, keeps repeating the same tips such as “Control-D to deselect” over and over. Once or twice per ten-minute lesson would have been enough for me.

A set of Preference settings is included on the CD and is necessary so that the user’s results match those in the book. Keyboard shortcuts are also provided. Both can be removed after you are done with the lessons. Photographs for the lessons are included on the CD. These photos and many screen shots of Photoshop are reproduced in the book as often as needed to illustrate the techniques being explained. They have used good quality paper and have coordinated the text and placement of figures very well.

The lessons are organized well. Commands used in a lesson are listed at the start of each lesson. Additional information is provided within the lessons using “Pearl of Wisdom” inset paragraphs. Sidebars describe other useful aspects of Photoshop or digital photography such as “The Nature of Channels” and “The Visible Color Spectrum Wheel.” There are also quizzes at the end of each lesson, which are not too difficult, and which can show you whether you understood the material presented.

Many, many Photoshop techniques and hints are covered. The author shares his opinion on the best way to do things (there's always more than one way in Photoshop) but discusses the other methods also. The most important part of the book is demonstrating what a particular command can do. Taken as a whole, you get an overall view of how incredibly powerful Photoshop has become. While the videos are about ten minutes long, some of the lessons take several hours. (Some of this may be explained by the fact that my PC is an 800 MHz Pentium III with 1.12 GB of RAM. It was not up to the task of one of the lessons – editing Camera Raw images.) One small complaint is that there are so many commands, menus, sub-menus and keyboard shortcuts covered in each lesson that I felt that some of the lessons were too long. Still, this book is excellent for people who want to learn how to use Photoshop CS well.

Exploiting Software, How to Break Code

This book by Greg Hoglund and Gary McGraw, reads like a sequence to “Hacking Exposed” and will be just as popular in the worlds of programming, security, and quality assurance. (Actually, we programmers are in a different universe than network administrators and everybody else.) It explains why software flaws exist, how to test for them, and why we need to worry about them. Real world examples are used to show how others have used these bugs maliciously.

A programmer will learn how to better sanitize a user provided input.

A network administrator will walk away with knowing how to set-up policies to prevent some of the more esoteric attacks.

Someone in quality management will know better how to audit code for exploitable flaws.

Just like “Hacking Exposed”, some people will worry that some of the information can be misused by a “Hacker.” But the book isn't really any help to a script kiddie. If someone just wants a copy of an exploit that they can use without understanding it, they will be disappointed. They will find themselves too overwhelmed with all the details. This book is just too heavy for someone with that kind of thinking.

It was written by a partnership of both a gray-hat hacker and

a white-hat from the academic world. This makes for a good mixture of theory and hands-on experience. While the book is talking about a software flaw, they mention how one of the co-authors used that kind of flaw to his advantage.

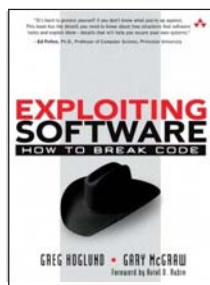
They not only explain the basics involved in finding and using problems like buffer-overflows or code injection to cause a problem with a program, but how it can compromise a program that gets on the network. It also explains how white-box and black-box testing can be used to figure out what the program is doing (not what it is supposed to do; you can read the marketing literature for that).

Most of the hacking books out there today focus on a specific side of security (network based, social engineering, etc). This book is all over the place and involves some very diverse audiences. Anyone who is involved with either programming, network security, or Quality Assurance needs to read this book and see what not to do and how to do things well.

It starts off in the first chapter with a small introduction into some software mistakes that have touched us all (do you remember the Mars Rover?). Then it spends several chapters on code that trusts their users too much or gives them too many privileges. Then it goes on to reverse engineering which will help you create a program's source code. The next two chapters cover programs that use the Internet, both on the server and the client side. Now it goes into what kind of user input can cause a problem. Finally, it spends three chapters on specific kinds of flaws, many different buffer-overflows and rootkits.

It won't be long before this book will be used as a college text book (if it isn't already) while it's on some best-seller lists.

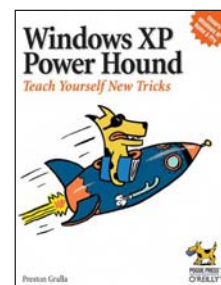

Windows XP Power Hound

As you probably are aware, there are a humongous number of books available on Windows XP, at least in part due to the lack of a printed manual to accompany Microsoft's XP CD. Oh yeah, XP has lots of electronic information/help built into the program with loads of additional stuff on line. But, like a lot of other users, I dislike reading help files on my PC and I object to printing copies of them except in special circumstances. Yes, I know that many people also dislike reading books; but the time spent looking up things in a good book can save you lots of time (and grief) when you plow



through a program that you don't know enough about.

O'Reilly's newly published **Windows XP Power Hound** is a good book. It is authored by Preston Gralla, a superior writer on computer stuff, and the author of **Windows XP Hacks**, a book that I reviewed in the Nov. 2003 Orange Bytes. I find Gralla's writing style easy to read and comprehend with enough humor to keep your attention. The 360 pages provide you with more than 400 "tips" on solving Windows problems, improving your understanding of the operating system, and making use of lots of built-in capabilities that are not well known. Gralla also makes recommendations of third-party software (freeware, shareware, and other) when he finds that Windows is insufficient in certain areas. The book is liberally illustrated to make it simple to apply the tips. However, I think that some of the illustrations are difficult to read and the paper quality leaves something to be desired. But, what can you expect for a \$25 book?

If you are a novice PC user and satisfied with using Windows in its default mode, then you probably won't want to buy this book. Likewise, if you are a PC guru, you may already know enough without reading this type of book. For the large number of us in between these extremes, there is a lot of very useful information and I believe that it is a good buy. The book's 15 chapters cover just about all the subjects that you should know about if you want to make XP run the way it should. Now, this is not a program manual, tutorial, or encyclopedia on Windows. But, it is a large collection of easy-to-follow and implement recommendations covering Windows' settings, appearance, operation, management, Registry, diagnostics, built-in utilities, as well as use of the Internet, e-mailing, security, networking and even some useful things on Microsoft Office. Spring Cleaning

Spring Cleaning is a convenient utility program for boosting the performance and regaining hard drive space on your computer. It includes a comprehensive system that is helpful for cleaning up your computer system. It is useful for removing old, unwanted or unnecessary files taking up extra disk space, removing junk from a registry, transferring data from an old computer to a new computer and backing up, restoring and archiving programs.

The home window has buttons for the following five utility groups:



1. **Applications** consisting of A) **UninstallApps** for removing applications by attempting to remove all executable files, registry settings, settings in configuration files, Dynamic Link Library (DLL) files, items in the Start Menu and shortcuts on the desktop, including applications that were installed before Spring Cleaning has been installed. B) **MoveApps** for placing the installation directory for a selected application to a new partition or hard drive including all the desktop shortcuts, registry settings and other configuration settings for the selected application are updated to the new location. Any customizations previously made in the application are preserved. C) **BackUpApps** saves a copy of an application, including existing settings and preferences, in a special, compressed format. D) **RestoreApps** restores a previously backed up or archived application. E) **TransportApps** uses features from the MoveApps and BackUpApps to place existing programs on a different computer. F) **Archive Apps** uninstalls an application and simultaneously creates a backup copy of the application on the hard disk or removable media. The application can be used, with its prior settings and preferences intact, with the RestoreApps. G) **InstallMonitor** tool keeps track of files copied on the computer during installation of an application and changes made to configuration files to insure complete removal of all related and registry files are completely removed by the UninstallApps tool. H) **Undo** can reverse changes made to the computer by many Spring Cleaning actions.

2. **Disk Cleaner** includes A) **Quick Cleaner**, a one step method to remove items in the Recycle Bin, temporary files and miscellaneous files such as lost cluster files. B) **Advanced Cleaner** is similar to the Quick Cleaner, allowing selecting from additional file categories; the files are listed for review and individual selection for deletion. Files may be backed up before permanent deletion. C) **Custom cleaner** provides for creating new categories of files for deletion.

3. **Registry Utilities** has A) **RegistryFixer** to locate and fix system registry errors, B) **RegistryCleaner** to remove unnecessary file references and options from the registry, and C) **RegistryEditor** to open RegistryMagic, an enhanced registry editor in order to make changes in the registry directly.

4. **Internet Utilities** consists of A) **HistoryCleanup** for removing links to recently visited Web pages, B) **CacheCleanup** for removing cached file contents of web sites that were visited; C) **ActiveXCleanup** for removing controls that are not wanted on the system, D) **CookieCleanup** for removing cookies that are no longer needed - a useful tool since cookies commonly contain login, registration and user preferences; E) **PluginCleanup** for removing plugins, which add a specific feature or service (e.g., Adobe Acrobat Reader) from the hard drive.

5. **Size Manager Utilities** includes A) Size Manager showing where and how the hard drive space is used, and B) **Duplicate Finder** tool for finding and deleting unnecessary duplicate files.

A **Log**, located under the Help menu in the home window, keeps track of messages generated whenever actions are taken

A help file is found in the Spring Cleaning application Help menu by clicking on AHelp Topics.@ The same information can be found in the PDF online manual. Assistance is available from Aladdin=s Technical Support web site: <http://www.aladdinsys.com/support> which has an extensive list of Frequently Asked Questions (FAQ). Emails can be submitted if the information sought is not found in the FAQs.

This program is accessed by double-clicking the Spring Cleaning icon on the desktop, by selecting **1) Start - Programs - Spring Cleaning - Spring Cleaning**, **2) selecting the Spring Cleaning option directly from the start menu**, or **3) by right-clicking on any executable (.exe) or shortcut (.lnk) in Windows Explorer, the Start Menu or the Desktop; the menu should have a Spring Cleaning option from which a tool may be selected to perform any task such as Uninstall, Move, Backup, Transport or Archive on that program.**

The system requirements are a 486, Pentium or faster computer using Windows 98, Me, NT 4.0, 2000 or XP with 16 MB RAM (32 MB for Windows NT, 2000 and XP), a CD-ROM drive and 30 MB of free disk space on your hard drive. My computer has a 2 GB CPU, 256 Mb RAM and Windows XP with SP2. Any disk utilities or antivirus programs running in the background must be turned off before installing. Installation from the CD is easy following the instructions and requires about one hour including the initial system scan to locate all of the program files. Subsequent opening of the program usually requires less time, depending upon the number of programs installed on the computer.

WinTasks 5 Pro

The last time that I reviewed this great Windows utility program was in 2003 (v. 4.15, Feb. issue of Orange Bytes). Well, it is still a great utility program with significant improvements to make it even better. Produced by LIUtilities (now a subsidiary of Uniblue Systems Ltd.), the software is basically a super process viewer (lots of bells and whistles) with relatively easy-to-use security features that nicely supplement your PC's anti-virus and firewall protection (which are your first line of defense against invading malware).



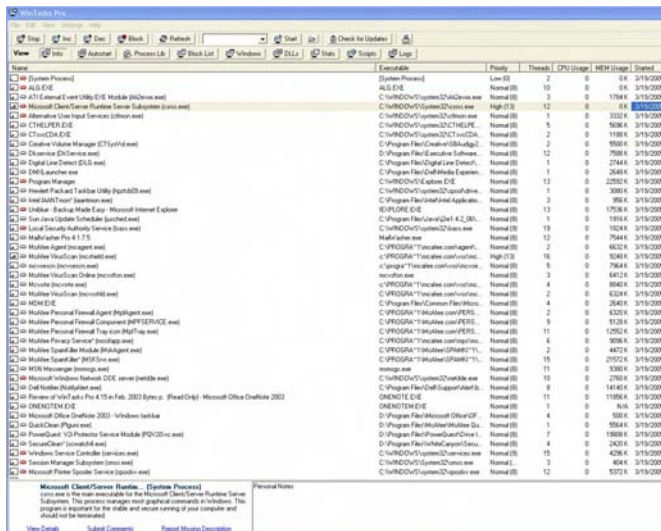
Although anyone can use its key features, folks who don't like to tinker with their system and depend primarily on default settings may find it more than they want to deal with. If you are a System Administrator, PC guru, programmer, or a user who likes to "tinker" with PC setting and maximize performance, then I recommend that you take a look at WinTasks Pro. You can download it for about \$50 (sometimes, even less) with a money-back guarantee or try it, fully functional, for free for 30 days. The link is <http://www.liutilities.com/products/wintaskspro/>. Although there is a Standard version of WinTasks (about 20 bucks less), the added capabilities in the Pro version will appeal to the aforementioned group of users. These include scripting language as well as memory-usage graphs, a startup manager, access to descriptive DLL information, advanced logging features, and Windows management tools.

Now, Microsoft's Windows operating systems come with a built-in process viewer, the **Task Manager** that you open by pressing the *Ctrl-Alt-Del* keys. For Windows XP, the capability is nice. It basically displays all the processes that are running on your computer, including the ones that automatically start when you turn on your PC. And, it allows you to delete unwanted processes/programs. Unfortunately, these are listed by executable name and path only; so, picking out the "bad guys" can be tricky. Your system's performance and the effects of the running processes are graphically displayed in terms of CPU usage/history, PageFile usage/history, totals of handles/threads/processes, and both physical & kernel memory. (If you want to know more about these terms, there are useful White Papers at the LIUtilities web site. If you get the WinTasks program, there is a good 22-page User's Manual in PDF format that provides an introduction to processes, threads, priority, etc., nicely illustrated with screen shots of all the graphics.)

When you open WinTasks Pro, the "user friendly" display allows you to view the processes running on your computer, the CPU and memory usage with graphs covering up to a 24-hour period, and total physical memory. The vendor's extensive online process library database (<http://www.liutilities.com/products/wintaskspro/processlibrary/>) is available to everyone

and provides simple explanations for (most) processes as well as author and official process name. The program automatically checks this library to permit safe programs to operate on your computer and help identify malicious ones.

You can also add your personal comments to each process, if needed for clarity and copy them to other computers. This can be a useful capability for System Administrators responsible for multiple PCs. Other displayed information includes process priority, number of threads, real-time CPU and memory usage, executable file properties, and version information. Using the available information, you can stop most processes with a single mouse click or change a process's priority.



When I first opened WinTasks, it showed 55 processes running. Only one process did not have any information other than file name and path. However, the path information was sufficiently clear to identify it; and WinTasks allows you to notify the vendor so it can be added to their process library. Another running process was identified as a Trojan and I was able to remove it. The process library provided the following information:

Over time, as you expand your software collection, your hard drive is likely to increase the number of automatically startup programs without your approval. This can lead to sluggish operation, performance degradation, and slow booting. One of my favorite WinTasks features shows a descriptive list of Autostart Programs (updated in real time), so you can temporarily disable or permanently remove ones that really aren't needed on startup and run in the background wasting system resources. While you could remove these manually by editing the Windows Registry (using the regedit.exe editor), I wouldn't try this unless you are a PC Pro! My relatively new PC showed 35 Autostart Programs and I was able to remove 12 of them! One deficiency in WinTasks: Descriptions of these programs is lacking with just the path displayed, making it more of a chore to determine which ones can safely be turned off.

Most software programs require multiple DLL files to operate and some of these are shared between programs. WinTasks lists all of the DLL files associated with each program along with descriptions and tells you when they are loaded.

The new version of WinTasks has a Block/Allow list where you can note unwanted (i.e. bad) processes and automatically prevent these from running. Other new features are an automatic update utility that keeps both program and process library information up to date, and a searchable process library with access to detailed information on malware as well as "good" processes.

The system that I ran WinTasks Pro on is a Dell Dimension 8400 Pentium 4 3.2 GHz machine with Windows XP Home Ed. Installation from a CD was fast and without problems and allowed me to specify where I wanted the program installed.

The vendor provides plenty of well-written White Papers and Tutorials that can be viewed online or downloaded (<http://www.liutilities.com/products/wintaskspro/whitepapers/>). Other useful products from Uniblue are **Winbackup** (a nifty utility to quickly and easily back up the files on your hard drives and **SpeedUpMyPC** (an easy-to-use application for fine-tuning your Windows operating system. ■

Preparing a Review Article for the Orange Bytes

The following suggestions for preparing a review article for the Orange Bytes are intended as a guide only. As a reviewer, your audience wants to know your opinion (as an end user) of the product (hardware, software, book) you are reviewing. Please fully identify the product, its vendor, and its cost (list, vendor discounts, & street) so that interested club members may be able to purchase it. Be objective, but balanced in your review in so far as plaudits and criticisms are concerned. Remember, you are reviewing for your colleagues and not for the vendor.

After you have tested the product or read the book, consider these questions:

- I. What is the product's stated purpose and does it meet it?
- II. Does it stand out compared to similar products?
- III. What are its major features?
- IV. Is it easy to use? Can a novice use it?
- V. Is it worth the money? Do you recommend it?
- VI. Can you quote or reference articles/reviews in the computer magazines?

The following list contains more specific questions that apply to either software or hardware:

- I. Requirements:
 - a. Operating systems?
 - b. Processor/speed?
 - c. Memory, Disk space, Video & Audio?
- II. Installation (do not overemphasize details):
 - a. Was it difficult?
 - b. Copy or write protected?
 - c. Does it allow drive and directory selection?
 - d. Does it automatically configure system? Can you control it?
- III. Information about your system:
 - a. Hardware?
 - b. Operating system? Version?
 - c. Memory?, Video display?
- IV. Documentation:
 - a. What is supplied? Manuals (paperback, electronic) Tutorial? Templates? Table of Contents? Index?
 - b. Was it clear, concise and helpful?
 - c. Is there a troubleshooting section?
- V. Product Support:
 - a. How is the vendor's tech support?
 - b. Does it cost anything?
 - c. Is it a toll call?
 - d. Does the vendor provide free Internet support?
- VI. About the product:
 - a. What comes with the product?
 - b. What is the cost (list & street)? Any special deals for user group members?
 - c. Version number and release date?
 - d. How difficult is the learning curve?
 - e. Would you buy/use the product?
 - f. Do you recommend it?
 - g. What don't you like about it?
 - h. What improvements or changes would you like to see?
 - i. Can the software be downloaded from the vendor's Web site; is there a free trial period before buying?
 - j. What warranty is there on hardware?
- VII. What are the Name, Address, Phone

number (including 800#), and WEB address (e-mail & URL) of the vendor?

The following list of questions applies to books:

- a. What is the subject matter?
 - b. Does the book meet its stated purpose?
 - c. Is it timely? If it is a revised edition, what is new in the current edition?
 - d. Is the title an accurate reflection of the content?
 - e. What level of reader capability is required? Who will find it useful?
 - f. Is it easy to read and technically accurate?
 - g. Is it well illustrated and are the illustrations easy to view?
 - h. Are there any major omissions and why are they important?
 - i. How are the key points highlighted?
 - j. Does the book have to be read in chronological order?
 - k. Are there any accompanying extras (like CDs)?
 - l. What do you like and dislike about the book?
 - m. Is the author well known in this field? Does he/she have a web site for errata/updates?
 - n. Finally, do you recommend it?
- After you have answered these questions, you should have enough information to write your review. Please be precise but do not make it so technical that only a few people can understand. Please advise the Orange Bytes Editor if you need graphics, pictures, or illustrations to get your point across.

general article or to any product that's reviewed. An expensive software package (\$300-700) deserves at least 1,300 words. An inexpensive program (\$50 or less) might have 500 words.

Reviews must be completed within 2 months so that the Reviews Editor (Ted Littman) can, in a timely manner, send a copy to the vendor. If you change your mind about doing the review, please call him (714)779-1936 ASAP to make arrangements for returning the product for reassignment. We hope you enjoy writing your review.

You can now e-mail articles directly to the Editor through the North Orange County Computer Club's Web Site: editor@noccc.org. Or just give the file on disk with a printout directly to Cathy Margolin (President), Jim Sanders (Publications Chm.), or Ted Littman on the next meeting day. If you e-mail your review, please send a copy to: reviews@noccc.org.

To transfer your article from your Windows word processor, click at the beginning of the article with your mouse, shift down arrow to the end of the article, then Edit Cut (^C), open your e-mail program, and Edit Paste (^V). This will convert the file to ASCII. If your article is too long to include in an e-mail, please save as ASCII file with a .TXT extension. Then zip the article (if lengthy) and attach it to your e-mail.

All documents should have flush left margins, and double carriage returns (skip a line) between paragraphs. The editors will bold your paragraph headings, etc., in order to obtain consistent formatting throughout the Bytes.

Don't use CAPS for emphasis; that's like shouting at someone! Also please spell check your article, and try to follow the ordinary rules of grammar. Don't use columns, tabs, indents, justification, hyphenation or formatting codes. (If columns or tables are absolutely needed, send us a hard copy to guide us.)

We look forward to seeing your review in print and on the NOCCC Web site!

Guidelines for Submittal

Important! Main Meeting

Karen McCauley from Mad Dog Multimedia (www.mmmm.com) presented us with their latest products in March.

As President Cathy Margolin opened the meeting, she made various announcements. For all Prius lovers, she mentioned that someone had hijacked the Prius website and stolen client e-mail addresses and passwords. In other news, CompUSA recently acquired The Good Guys.

Cathy also made an announcement significant to NOCCC: The 9:30 AM New Technology SIG has been discontinued and replaced by the Digital Photography SIG (which moved from 2:30 PM). Digital Photography is rising in popularity and is a great offering for the 9:30 AM timeslot. Other SIG changes might be made as well, to meet the needs and interests of our members.

For wireless Internet access, both Long Beach and Fullerton offer such access for free in their downtown areas. Most airports, such as the Long Beach Airport, also offer wireless access. However, there may be a fee involved in airport wireless Internet access.

There was a discussion on security issues like spyware and viruses. A new anti-spyware product is offered for free at www.anonymizer.com. (This is in addition to the popular Adaware and Spybot - Search & Destroy products.) Trend Micro (www.antivirus.com), who offers FREE HouseCall on-line virus scanning, now offers spyware checking features in their anti-virus products, like PC-cillin. A FREE edition of AVG Anti-Virus is offered at www.grisoft.com.

Cathy introduced Karen McCauley,

Mad Dog's Director of Marketing -- and maintainer of their impressive website. Karen began her presentation with an explanation of Mad Dog Multimedia. Mad Dog is a three-year old privately held corporation, started in August 2001. In its short life, the company has grown to \$60 million dollars in annual sales. They sell products geared toward small and medium-size businesses, as well as multimedia home users. Their motto is "Uncompromising Excellence."

Mad Dog products are sold at all major software retailers -- CompUSA, Fry's, and others. They use the Internet for all other sales. They also contract out most of their business. For instance, although they are based in San Diego, they store and ship their products out of another company in Utah. Their technical support is also in Utah.

They do not manufacture their products. They merely provide specifications to well-known manufacturers like NEC, who then make the products. Mad Dog handles everything else in dealing with the products -- marketing, sales, technical support, warranties, rebates, returns, and all other aspects.

Although Mad Dog offers some fairly common products, like CD/DVD burners and graphics accelerator cards, they offer those products with the BEST SPECIFICATIONS AND WARRANTIES in their classes. For instance, they offer 2-year warranties on optical storage products, 5-year warranties on their SurePower PC power supplies, and lifetime warranties on all graphics and sound cards.

As an aside, Karen gave us some helpful information about rebates. Although it might seem like rebates are processed by manufacturers themselves, they are actually done by special rebate companies. These companies contract most of their labor out to work-at-home individuals who process millions of rebates in a cost-effective manner. Karen recommended ALWAYS making copies of rebates before sending them in. She also mentioned www.salecircular.com, which provides information on rebates

for most, if not all products.

Karen briefly presented all of Mad Dog's products, including the following:

- MegaSTOR 7-in-1 external combo CD/DVD burner, which provides 4x double-layer burning. This includes a watered-down version of the Nero software. (The data storage capacity for a single DVD is 8.5 gigabytes.)

- Dominator internal combo 52x CD-RW, 16x DVD-ROM. This also includes the watered-down Nero.

- Dominator external 56x CD-ROM. (Mad Dog is #1 in sales for the CD-ROM market.)

- Dominator internal and external floppy drives.

- Dominator and Conqueror model AGP graphics cards, manufactured by Nvidia. These all use DirectX 9.0.

- Dominator and Predator Radeon graphics cards, with ATI chipsets.

- 3 sound cards -- Entertainer (8-channel), Predator (6-channel), and Prowler (4-channel).

- Techie Toyz -- Special versions of hardware that add pizzazz to PCs. These are POPULAR among PC gamers -- and teenagers and young adults in general. (This generation customizes their computers, just as earlier generations had once customized cars.) Techie Toyz include fans that light up or have hip colors, floppy and IDE cables that light up or have hip colors, colored screws, and hip external power supplies. These components really look hip in transparent computer cases. Apparently, Techie Toyz are in such high demand that retailers can't sell them fast enough!

Cathy asked what Mad Dog products might be in the works for the future. For now, Karen had only one to mention: an internal PC peripheral that acts as a cup holder, charger, and cigarette lighter, all in one.

Karen and Mad Dog were kind enough to donate a MegaSTOR 7-in-1 combo CD/DVD burner for our raffle. She also donated two Techie Toyz -- a lighted fan and a lighted cable. These will be given away in next month's raffle. Thus, you have a great reason to attend next month's meeting!

Computer Aided Investing (CAI) SIG

Market Review

The DJIA went up in February, way up, from 10,400 to nearly 11,000. This trend continues the rally that began the third week of January. Our predictions are bullish for March. The indicators of an oversold position made last month by amateur-investors.com turned out to be too pessimistic. This month, the majority of the attendees expect the upward trend to continue.

Efficient, Inefficient, that Is the Question.

A controversy regarding whether the market is perfectly efficient or not has raged among economists for years. Now we can reveal the truth. Both sides are wrong. The market is somewhat inefficient because some investors do not attempt to capitalize on minor fluctuations. Typically, they purchase a broad index fund and hold it for the long term. On the other hand, the market is somewhat efficient because some investors are actively seeking to capitalize on market efficiencies to gain an advantage. The message to be taken away from these observations is that the best active investors can detect market opportunities and capitalize on them. It is also important to note that no one

strategy will work in all market conditions. Opportunities for beating the market occur regularly. The challenge is to find them before the market returns to equilibrium (or even swings too far in the other direction).

Data Analysis

This month we turned our attention to keeping in front of the pack. We are exploring the capabilities of Excel to portray and analyze stock data to not only uncover new opportunities but also to verify half-baked claims that are so prevalent in today's investment marketplace.

To launch this endeavor, we investigate add-ins that are helpful in investment data analysis. We also described how Excel may be used to represent, modify, and graph a variety of investment data extracted from tables, the internet, and databases. Scatterplots and histograms allow us to detect trends embedded in a noisy environment. In future meetings, we turn to calculating and graphing various statistical characteristics of one or more financial variables. After these basics have been mastered, a variety of statistical methods including regression and time series will be applied to investment data.

Next month Bob will return to the podium. ■

Assistive Technology SIG

The Assistive Technology SIG had a demonstration of the features in Adobe Reader and Microsoft Reader programs that can assist people with low vision to read documents and books. Both programs use Microsoft's speech technology to read text. This can be a very helpful to a user who cannot read the text on the screen, or has difficulty reading on-line. It can also be used by people who have difficulty using the keyboard and mouse to scroll through a

document. Some people just have a problem reading for an extended period of time. A program which will read the text can be useful in all of these situations. There are audio books available through the Internet but these cost money and not everything is available in the Audio Books format. A program which will read to you only requires that the file is in the format that the program uses. Of course, the voice that is used isn't as good as a person reading the text, but it is very understandable.

There are many books available in Microsoft Reader format. There are books that are free and then there are other books which cost money. This program also allows you to enlarge the size of the text displayed on the screen. It even highlights each word as it is read. This can be helpful if you are using the text to help you understand the spoken words. There are many other useful features to this program and one of the biggest is that it is free and downloadable from the Microsoft web site.

Adobe Reader (formerly Adobe Acrobat Reader) had the capability of enlarging text on the screen. It will also read the text to you. Many programs use the PDF (Adobe Acrobat) format for the User Guide or the Help file. This makes it very easy for a person with low vision (or even slightly aging vision) to read the PDF file. The PDF format is becoming very common. Many web sites have documents in PDF format which can be read with Adobe Reader using all the features of the program to enlarge the text, etc. It is even becoming more common for other programs to save documents in PDF format. PDF files have a wonderful "search" capability. I use this frequently because it allows me to search for any string of characters, not only words, and to scan quickly all the locations in the document which they occur. An example of this is a monthly statement downloaded from a brokerage firm. It is possible to search on the name of a security, which may just be a string of letters, or search on a dollar

amount. This is much easier than looking at each page of the document for the information you need.

It is also worthwhile to look at the abilities of all the programs which you use to determine if they have capabilities to enlarge text on the screen or to read the text to you. Many programs have interesting abilities that most people haven't discovered.

If you have difficulty in looking a web pages because of low vision please come to our next meeting. We will have a special demonstration of the IBM Web Adaptation Technology program by Mark Borison. The presentation will be in Irvine Hall immediately after the General Meeting.

Digital Imaging Sig

A demonstration of the interactivity between InDesign (ID) and Photoshop (PS) showed among other things, that the purchase of PageMaker by Adobe resulted in a very similar publishing program (surprise, surprise) with a few more bells and whistles. One caveat about pictures imported into ID from PS is that for purposes of ease of placement, the PS pix appear to be quite grainy, but are in fact printed with all the clarity desired. Speaking of clarity, the pixels per inch resolution of imported photos need not be more than 150 for mass publications. For instance, local printers have said that pix submitted for use in the Register at more than 150 have to be redone. Resolution at 300 ppi is generally suitable for

high end magazines and 600 for fine art.

As a tiny example of the depth of control in ID, as in other high end publishing programs, vertical line spacing can be established with three(!)decimal places. The common default spacing of 12 points can become 13.564 points. Horizontal character spacing allows similar accuracy. Twelve points = 1 pica = 1/6 inch. If you're into this, get friendly with picas and points. Forget inches!

For the second part of the sig, the major portion, Cathy Margolin explained some basic, necessary suggestions about picture composition, e.g., separating the field into thirds before shooting, and photographing action in such a way that the eye is led into the picture, not out. Happily, for those into product photography, Cathy demonstrated an inexpensive, very effective background setup made of breakdown PVC pipes. She avers that Inventor George created it.

With any luck, the next meeting will feature members showing the most helpful tips and tricks they've learned about digital imaging the last few years. ■

PC Q&A SIG

This month I talked about the solution that I came up with for an annoying problem with my Shuttle computer. For the first six months that I had the machine I was mostly only using it for club meetings once a month. During that time, I had the CR2032 back up battery go bad probably 3 times. The first time it happened, I stole a battery from an old mother board and had no idea what state it was in. The second time I replaced it, I found a battery that had been in a drawer for I don't know how long. The third time, I replaced it with a battery that was one of five that I picked up at the ACP Swapmeet for a buck. Even though it was very unusual, I thought maybe all of them had been on their last legs anyway. The next time I replaced the battery, I went to the store and bought a

name brand battery with a fresh date code. I took note of the installation date, plugged the computer into the power outlet and checked it periodically. Almost two months later it was still OK and I thought the problem was solved.

Shortly after that the battery was bad again. To shorten the story, I finally measured the current draw on the battery and found it to be 508 microamps. I looked up the capacity of the CR2032 and found it to be rated at 220 mah (milli amp hours). If you do the arithmetic, that works out to about 18 days to drain the battery. That is about 1000 times faster than it should be. By the time I got this sorted out, the warranty had expired. My solution to the problem used the get a bigger hammer approach. I took one of the dead CR2032 batteries, used the Dremel Tool and a cut-off wheel to slice it open. I removed it's innards, found a 6" long piece of two conductor wire and soldered one wire to the plus side and one to the minus side of the battery shell. The other end I connected to a two cell battery holder for AA size cells and taped it inside the case. The common rating for AA alkaline batteries is 2850 mah. At that rate I figure it should be good for about six months before I need to replace the batteries.

At the April meeting, I plan to have bootable CDs be the fall back topic if the Q&A portion runs out of Qs before we run out of time. If you need to boot into DOS, CDs are much faster than floppy disks. ■

to share the calendar pages and other information. Create a new folder if necessary.

5. Use the mouse and the arrow keys on the computer to place the cursor at the beginning of the file name in File Name. Type **http://**. Figure 3 shows an example.image

7. Verify that **Open Saved Web Page in Browser** is selected and that you're connected to the Internet. Then click **Save**.

The saved calendar will open in Internet Explorer. To view calendar con-

tent when you've installed Service Pack 2, click **Allow Blocked Content** on the Information Bar. Figure 4 shows a sample calendar saved as a Web page.

Additional Ways to Access Family Data

There are lots of ways to view a shared calendar once it's available on the local network. The same is true of any shared folder. Simply open **My Network Places**, and choose the available shared folder, or click **Add a Network Place** if it isn't available and browse to it.

You can also take the data with you or access the information remotely. The Outlook Calendar can be synchronized with the calendar on your Pocket PC or laptop. And if your computer is set up for **Remote Desktop**, you can access the information from your local coffee house, school, a work computer, and soon, from a from a myriad of new wireless gadgets you'll be able to wear on your wrist or carry in your pocket.

You can also access data that isn't shared on a network. For instance, if Mom has a **Smart Display**, she can view what's on the Media Center screen from any room in the house. Once a calendar is saved as a Web page, you can use Display Properties and the Desktop tab to browse to the saved calendar pages and choose one to use as the Desktop image. You can even connect your computer to a television set and show the calendar there.

Of course, you can always publish the calendar pages and other data to a Web site hosted by your ISP, but remember to assign a password and configure other security features so the information is available only to family members. Whatever you do, remember—you purchased your Media Center to have fun. Make sure you spend more time playing than organizing your family and friends!

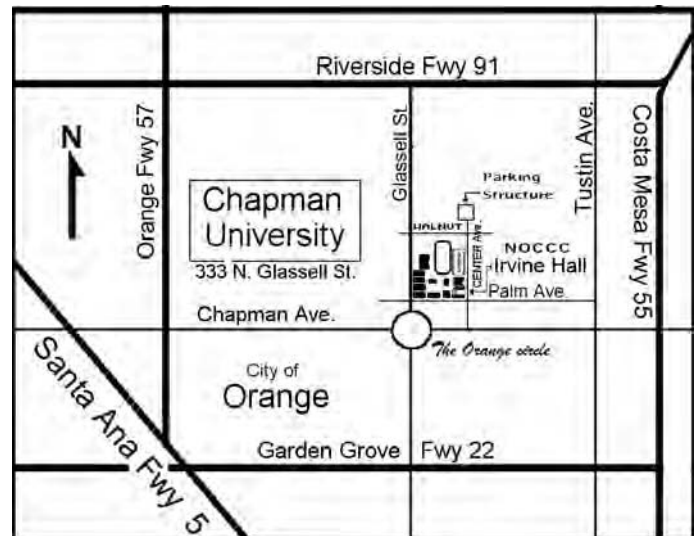
