Preparing a Review or Article for the NOCCC Orange Bytes

here are two sections in the NOCCC newsletter, the Orange Bytes, where our members can contribute reviews and articles. They are the **Computer Talk** section and the **Product Reviews** section.

Articles in the **Computer Talk** section can be about almost any computer or technology related experience that you have had. For example, getting a new ISP, getting an ISP to change your connection speed, converting a PC to Linux, using a MacIntosh PC for the first time - the list is endless.

The **Product Reviews** section can be a review of almost any type of computer hardware, software, or book about a computer-related topic. The item can be something you have bought or obtained from the NOCCC. Once you agree to do a review, you will generally have 2 months to complete it. These reviews are published in this newsletter, the Orange Bytes.

The NOCCC Reviews Editor, Ted Littman, (714) 779-1936, reviews@noccc.org is regularly sent copies of books and software by the publishers for review by our members. We need NOCCC members to take these items and commit to reviewing them promptly. The reward for doing a review is that you get to keep the book or software. If we do not review them, they may stop sending these items in the future.

NOCCC Elections at the June 2011 Main Meeting

Please consider becoming more involved in running the NOCCC. **During the June 2011 meeting, we will be holding our annual elections.** You must be at the meeting to vote. All positions on the NOCCC Executive Board are to be filled. While mostly taken from the Bylaws, the summary below is not all-inclusive.

NOCCC Executive Board

The NOCCC Executive Board "subject to the limitations of those bylaws, shall debate, establish, amend, and update the policies for all the affairs and business of the NOCCC."

"The Board shall concern itself with the disbursement of all NOCCC moneys. The Board shall consider the budget and such additional expenditure requests as are submitted by the president, and shall authorize such expenditures as it considers wise and appropriate."

The NOCCC Executive Board consists of four officers, eight elected directors, and ex-officio members. There are four officers of the club: President, Vice-President, Secretary, and Treasurer.

Duties of the President include:

- Represent the NOCCC to the community as the chief executive officer.
- Set the agenda for and presides at all general meetings of the club.
- Set the agenda for and presides at all meetings of the NOCCC Executive Board.
- Appoint members to chair all standing and special committees and appointed positions.
- Receive, on behalf of the NOCCC, all contributions to the club.

Duties of the Vice-President include:

- Assume the duties of the president in the president's absence.
- Assume special duties as may be directed by the president.

Duties of the Secretary include:

- Establish and maintain a record of all NOCCC correspondence, and attend to correspondence as directed by the president or the Executive Board.
- Establish and maintain records of the proceedings of all regular and special general meetings, and of the Executive Board meetings.
- Establish and maintain a record of all real or personal property acquired by the NOCCC and cause said

property to be permanently identified as property of the NOCCC.

Duties of the Treasurer include:

- Receive and deposit into the NOCCC accounts all moneys received.
- Establish and maintain an accurate journal of all receipts and disbursements of NOCCC money.
- Report at the regular general meetings a summary of the financial status of the NOCCC.
- Suggest, if appropriate, to the Executive Board that an audit be made and reported to the general membership.

Elected Directors

The eight elected directors are on the Executive Board and, along with the four officers, address any issue that comes before the Board.

Ex-officio members of the Executive Board

Ex-officio members of the Executive Board are the immediate past president, editor of the club newsletter and the webmaster. The President appoints the editor and webmaster.

Other Appointed Positions

These positions are Membership Chairman, Reviews Editor, Public Relations, Business Solicitations/Lecture Series, Classified Advertising for Members, Commercial Advertising, Webmaster and Programs/Speakers Coordinator. Contact the current club President if you are interested in any of these positions.

Save Your Parking Permits!

To offset the cost of parking in the Lastinger Underground Parking Structure, the NOCCC Board approved a motion to give each member two NOCCC General Drawing raffle tickets in exchange for the Lastinger-parking permit. Turn the bottom-half "receipt" part of your permit to the Rafflemeister on the same day or hold it until the next meeting. Gerry Resch, the Raffle Leader, will exchange it for two raffle tickets.

The reason for this is that the NOCCC Board has found that some people are not attending meetings or not renewing their memberships because of the parking situation. Chapman University has allowed us to park in the Lastinger Parking Structure under Wilson Field for only \$2 for the whole day of our meeting; normally \$2 is good for only two hours. The advantages of parking there are clear; you don't have to drive around looking for a legal spot (remember, don't park on the private home side of the street), the car doesn't get hot and you don't have to parallel park. There is even an elevator available to get down to the parking area. Hopefully, the two raffle tickets, which would normally cost \$2, will be a small incentive to get people to come to meetings and to remain NOCCC members.

Consignment

The NOCCC Consignment Table will be available during the June 2011 meeting in the lobby of Irvine Hall. It is open on even months, the same as the e-Waste collection. For your information:

- 1) Only current members can place items for sale, but non-members are welcome to purchase items from the table. This is a great place to get some money for your surplus computer items, and help the NOCCC at the same time.
- 2) The consignment table operates on a 90/10% basis with the owner getting 90%, and the Club treasury 10%.
- 3) You can fill out a Consignment Table User List and item tags at the table: The user list and each tag must contain:
 - a) Seller's name
 - b) Seller's NOCCC membership number
 - c) Item name and description
 - d) Item asking price
- 4) The seller may pick up all items and/or money at any time, but **no later than 2 p.m. on the day of sale**. Any items and/or money not picked up by 2 p.m. will become the property of NOCCC and will be subject to disposal at the Club's discretion. The club has no storage room available for unsold items
- 5) NOCCC is NOT RESPONSIBLE in any way for items bought and/or sold at the Consignment Table. Each item is placed and sold on an AS-IS BASIS.

E-Waste Collection

California disposal laws have made it illegal to put monitors and computers in the regular trash. **Omni Technics, Inc.** will be at our regular meetings to collect E-Waste **on even months**, so bring your "junk" in **June**.



Word Tips



Can't Select and Edit Graphics Elements

elicity noted that until yesterday, when inserting graphics, text boxes, WordArt, and etc. into her documents she was able to view, select, and manipulate them in Print Layout view. Now the only view in which they show is in print preview, and when I select one of the items, all the editing and formatting tools are grayed out. Felicity is wondering why she can't work with these items as she previously did.

It sounds like the problem is that the Picture Placeholders setting has been turned on. You can control this setting in this manner:

- 1. Choose Options from the Tools menu. Word displays the Options dialog box.
- 2. Make sure the View tab is displayed.



- Make sure the Picture Placeholders check box is cleared.
- Click on OK.

Your pictures should now again be accessible as you are editing your document.

Quickly Inserting the Date Your Way

everal other *WordTips* explain how you can understand and change the default dates used by Word. Some people prefer a simple way of inserting the date, in their preferred format, using AutoText. To set up this method of date entry, follow these steps:



- 1. Position the insertion point on a blank line.
- 2. Choose Date and Time from the Insert menu. Word displays the Date and Time dialog box. Choose the display format that is closest to what you want.
- 3. Make sure the Update Automatically check box is selected at the bottom of the dialog box.
- 4. Click on OK. The date, using the selected format, appears in your document.
- 5. Select the date field and press **Shift+F9**. This displays the actual DATE field coding.
- 6. Change the format within the quote marks to reflect your final format.
- 7. Press **Shift+F9** to display the DATE field results instead of the field coding.
- 8. Select the date field again.
- Choose AutoText from the Insert menu. This displays a submenu.
- 10. Select New from the submenu. Word displays the Create AutoText dialog box.
- 11. Type the word Date in the Name field.
- 12. Click on OK. Your DATE field, properly formatted, is now saved under the Date AutoText entry.

Now, to use the entry, type the word Date and then press the **F3** key. The word Date is replaced with your DATE field, as you saved it in AutoText.

Drawing Simple Objects

rawing objects that involve lines (such as lines and arrows) requires only that you perform a few steps:

- 1. Display the Drawing toolbar and select either the Line or Arrow tool by clicking on it with the mouse. (You may need to click the AutoShapes menu first.)
- 2. Move the mouse to the starting point for the line or arrow and click and hold the mouse button.
- 3. Move the mouse to the other end of the line and release the mouse button.

As you move the mouse in Step 2, notice that Excel displays a line that shows the approximate size, angle, and position of the line or arrow you are creating. When you release the mouse button (step 3), the line or arrow is redrawn in its final position and appearance. If you are drawing an arrow, the arrowhead appears at the end of the line where you ended your drawing (Step 3).

As with lines, the other simple objects only require two points to define them. Each of them, regardless of the final shape, is defined by a rectangle. (Yes, even ellipses and circles are defined by a rectangle—one that contains the entire shape.) You only need to do the following:

- 1. If you are using the Drawing toolbar, select the drawing tool by clicking on it with the mouse. (You may need to click the AutoShapes menu first.)
- 2. Move the mouse to one corner of the rectangle that will define the boundary of the shape, typically the upper-left corner, and click and hold the mouse button.
- 3. Drag the mouse to the opposite rectangle corner (the lower-right) and release the mouse button.

Notice that as you perform step 2, the shape appears on the screen and is dynamically sized as long as you continue to hold down the mouse button and move the mouse. When you release the button, the object is drawn in its final size and shape.

If you want to create a square or a circle, both of which are special forms of rectangles and ovals, Excel makes it easy. All you need to do is hold down the **Shift** key as you drag the mouse to the second point. Thus, you click the mouse, hold down **Shift** as you move the mouse pointer, and then release the mouse button.

Resetting Toolbars to Their Default

Excel is very flexible. You can customize your working environment to your heart's content. You can change menus, the toolbar, viewing and printing options, and many more variables. There may come a day, however, when you want to reset the Excel toolbars structure their default condition. When you do this, all the toolbar buttons and their order will be set to the same condition they were when you first installed Excel. If you want to reset the Excel toolbars, perform these steps:




- 1. Choose Customize from the Tools menu. You will see the Customize dialog box.
- 2. Make sure the Toolbars tab is selected
- 3. In the list of available toolbars, select the one you want to reset.
- 4. Click on the Reset button. You are asked to confirm resetting of the toolbar.
- 5. Click on OK to reset the toolbar.
- 6. Repeat steps 3 through 5 for each toolbar you want to reset
- 7. Click on Close to dismiss the Customize dialog box.

Changing Font Color

ormally, Excel displays information using black type. This is acceptable if you are printing to a regular printer, but many people these days have color printers. Additionally, you may want to simply use different colors for displaying information on the screen. You can change the font color used by Excel in the following manner:

1. Choose the cells whose font color you wish to change.



- 2. Choose Cells from the Format menu. Excel displays the Format Cells dialog box.
- 3. Make sure the Font tab is selected. Using the Color drop-down list, select the color you want used for the information in the cells you selected in step 1.
- 4. Click on OK.

There is another way to change font color, and you might find it a bit faster. You can change font color using the toolbars in this manner.

- 1. Choose the cells whose font color you wish to change.
- Click on the down-arrow at the right side of the Font Color tool on the toolbar. This displays a color palette.
- 3. Click on the color you wish to use.

At this point the color of the information in the selected cell is changed. You may also have noticed that the color bar at the bottom of the Font Color tool changed, as well. This means that in the future, all you need to do is select cells and click on the tool to change their font to the same color.

Adding Your Own Menu Items

s you customize Excel to meet your particular needs, you may want to add a menu item or two. For instance, you might want to add a menu item to run a macro you have designed. To add an item to a menu, follow these steps:

- 1. Select Customize from the Tools menu. Excel displays the Customize dialog box.
- 2. Make sure the Commands tab is selected.
- 3. In the Categories list, select either the category of commands you want to add to the menu, or select Macros if you want to add a macro to a menu.

- 4. In the list of available commands for the category, select the one that you want to add to a menu.
- 5. Drag the selected command to the menu where you want it added. The menu appears as you move the selected command over the command name.
- 6. As you reach the point where you want the item to be added, release the mouse button.



Hanging When Opening a Workbook

ary wrote about a problem she was having with a workbook—whenever she would double-click it in Windows, Excel would start, but then freeze before opening the workbook completely.

If this is a problem that happens whenever you open any workbook, it could be because one of the startup files being opened by Excel is corrupted. You can determine if this is the case by instructing Excel not to open these files when it starts. Use the Run option from the Start menu, and run Excel by entering in either of the following lines:

"C:\Program Files\Microsoft Office\Office\Excel.exe" /Automation

"C:\Program Files\Microsoft Office\Excel.exe" /Safe

The quote marks are mandatory, and there is a good chance you will need to change the path to the Excel.exe file. When Excel starts with either the /Automation or /Safe switches, it doesn't load the startup files it normally does. Once Excel starts, turn off automatic recalculation by choosing Tools | Options | Calculation tab and making sure the Manual option is selected.

Now try to open your workbook. If it opens, then you can assume that the problem is somewhere in the startup files. Track them down and make changes or deletions, as necessary. (Other *ExcelTips* issues have discussed startup files and their locations.) If the workbook doesn't open, then the problem is

with the workbook itself; it may be corrupted and you may need to recreate it.

Finally, it could be that there really is no problem with the workbook at all. If the workbook is very large and was created in an older versions of Excel, and you are opening it in Excel 2003 or Excel 2007, then there could be a long delay as the workbook is opened. This is because the newer versions of Excel rebuild the calculation tables associated with the workbook; rebuilding those can take some time to do for workbooks with lots of calculations.

The Seventh Son of Windows Desktop Gadgets

Introduction

indows Vista introduced a new feature called the Sidebar, which was a narrow section of your Desktop where you could have small applications running called Gadgets. These Gadgets could be moved out of the Sidebar and anchored somewhere else on your Desktop, if you wished, but still the Sidebar application had to be running.

In Windows 7, there is no longer any Sidebar, but Desktop Gadgets are still present, and you set them up in a new Control Panel applet of the same name. (In Windows Vista, the Sidebar was on by default, whereas in Windows 7 there is no Sidebar and any Gadgets you want must be configured in Control Panel.)

Windows 7 Gadgets

The Gadgets present in Windows 7 are the same as those provided by Vista, with an additional one that is connected to Windows Media Center. These Gadgets are mini-applications designed to use web technology so as to provide real-time access to information of one type or another available through the internet. The built-in Gadgets are these:

- a Calendar application which shows the month, day, year, and day of week. If you click it, you will see the entire month
- a Clock which can be configured to show one of 8 different clock faces and any time zone
- a CPU meter which shows two analog style dials measuring current memory usage and CPU utilization
- a Currency converter
- a Headline Feed of RSS feeds that you are subscribed to via Internet Explorer
- a Media Center gadget that shows a revolving set of links to various parts of Windows Media Center
- a Weather gadget which can be configured for any location in the world
- a Stocks gadget for tracking stocks
- a Picture Puzzle where you slide tiles around against a timer
- a Slide Show gadget for showing the photos you configure for it

Other Gadgets

There are many other Gadgets that can be downloaded from the internet and installed, if you so desire...


Windows 7 Gadget Options

If you click on the Show Desktop area of the Taskbar in Windows 7 (a narrow rectangular area on the extreme right end), then you will see the Desktop with its Gadgets (if any.) In Windows Vista, when you clicked on the Show Desktop icon of the Quick Launch Bar, the Gadgets were not visible.

Gadgets can be shown on your Desktop in Windows 7 even if you are not on line with an internet connection, but they will in this case feature a time stamp which shows how out of date the associated data is. Some of the Gadgets, e.g., the Calendar, can be toggled between various sizes. Some of them have Touch capabilities for those users who have a touch screen attached to their PC.

When Outlook Dies, Windows Live Mail Lives

I had been using and enjoying the features of Microsoft Outlook 2007 since 2007, never imagining that one fine day I would log in only to see a message saying something to the effect that Outlook was in use and that I had to close a "pst" file, or face the consequences. In fact, MS Outlook simply stopped. I was unable to move appointments, open an email, or do anything that I was accustomed to in order to make my activities on the computer enjoyable and efficient.

For lack of a better option, I decided to turn to Windows Live Mail (WLM), a part of the Windows Live Essentials suite that was already installed on my system along with my favorite photo management program and even my antivirus app.

Since this was already present, I didn't have to do much, except launch it. It happily grabbed my mail downloads from Gmail and politely asked me if I wanted it to be the default email program. I said "Yes!"

I was pleasantly surprised. I use Gmail but I was pleasantly surprised. I use Gmail but only for the convenience of having an online calendar and email program that I could access from any computer. As far as WLM, I would say the only real inconvenience is the loss of my Outlook calendar, but I can manage using the online Google calendar whenever I'm on my desktop.

First Impressions

When you first use WLM, you are obligated to establish a connection with your ISP (Internet Service Provider). Since I use Gmail/Verizon/Hotmail/Yahoo, I can add these by going to the accounts Tab, clicking on the Email icon and adding an account. Since I sync everything on Gmail's server, there is no need to do this. In fact, it gets kind of confusing when lots of email accounts are listed, at least for me. So I stick to my Gmail account and things have been going smoothly.

Tabs and Ribbons

Cosmetically, the interface is clean, uncluttered and easy to understand. You start with a Quick Access Toolbar and tabbed ribbons familiar to those of us using current MS Office apps. The tabs are: Home/Folders/View and Accounts. Let's take a peek at each.

The Home tab is where you compose, create Photo emails, mark as junk, and for those Calendar challenged like me, an opportunity to add a message to that calendar. This may be the workaround I need. Anything to save typing! You will see a sign in request on the right side. You don't have to be a member of Hotmail or Windows Live or sign in. I do so under my Hotmail name, as this allows the computer to sync and recognize my name on many other sites, such as Facebook, Windows Live Mesh, and others too tedious to mention here. I am a social networker, and am comfortable with such arrangements, but you don't have to subscribe to these. The email program will still work for you, happily. I really like the Photo email option. In the example shown above, notice how the pictures I chose are inserted as an album, and also that a picture tools and a photo album tools ribbon is provided. Even though that may be considered overkill on Microsoft's part, it is still handy in case you want to do a bit more work before sending your pictures out.

Also useful is the View ribbon. Here you can change the layout of your screen. My favorite button here is the Account color – among others, you can change your theme to Fuchsia or Smoke. Other colors you can use are Lime or Twilight. Someone must have had a sense of humor when they wrote this app. But you can use a different color for multiple accounts, so there is a reason for this virtual rainbow.

The Accounts ribbon is one I hardly go to.

Anything here is handled elsewhere. In fact, IMAP folders or Newsgroup is a bit beyond what I need in my email program, so I leave these alone.

Summing Up

In using WLM, there is little to worry about. It will download your messages, keep your appointments once you enter them, and handle your contacts. In fact, it handles contacts only too



well. I was happy to see that it has the uncanny ability to find and list my Facebook contacts as well as the ones imported from MS Outlook. It won't list their emails or any unavailable information, but it does three things I like. It gives me a picture of the friend from their Facebook profile, a link to their online Facebook page, and whether they are currently there. So

even if I'm not online, I can quickly get to their page and see what my fellow networkers are up to. LinkedIn also seems to be important enough to be included in this feature.

No Calendar Sync

A quick mention of the Calendar – since it does not sync with Google calendar, unless I have a lot of time to re-enter my appointments, Google will have to be my source of information. I have read recently that Yahoo Mail will sync with WLM and Google, but have not had the time to really investigate this. With the way that the Internet is combining profiles and individuals' information, it would just be one more intertwining of online information. Perhaps in time there will be a better way to do this.

I will miss MS Outlook. But I will not miss the fact that one fine day it just stopped working, gave me strange error messages, and was unwilling to be reinstalled properly. I know that there are always more options, and WLM is a fine option. Being downloaded from the Internet, it is always up to date and free. Try it if you want to use a local email program with lots of features and an uncomplicated interface.

Microsoft Security Essentials

ver the years, ever since my first encounter with a computer virus in 1987, I have used a number of antivirus applications along with firewall software. As the Internet grew in the late '90s I had to add anti-parasite software and other anti-malware applications to the protection arsenal. Some of this software was free; others were very expensive both to purchase and to maintain. Some used tremendous amounts of computer resources which slowed down the overall operation of the computer. The cost in money and/or resources wasn't necessarily directly related to the usefulness of the application. However such protection was probably a necessary evil to prevent problems on my computer from the "invaders" that existed then and now on the Internet.

Most anti-malware applications seem to be growing in size as each manufacturer tries to "cover all the bases". Unfortunately with the increase in size and coverage comes an increase in complexity. Now Microsoft has released an improved version of their Security Essentials (MSE) software that is easier for the user to install and operate. This application protects your computer against viruses, spyware, worms, trojans and other malicious software. In addition it is an easy to install FREE download from Microsoft. The only catch is that you must have a legal copy of Windows on your computer. The installation program does a check for Genuine Windows validation. The software runs on XP, Vista and Win 7 operating systems (OS). However, I have only been using it on Win7.

It does sound like it must be a resource hog to be able to carry out all of these functions. But the testing results I have seen show minimal effect on overall computer operation. Yes, there is reduction in the speed of processing web pages, e-mail, etc., when using the real-time protection. But compared to other software carrying out the same functions, the difference in speed is insignificant and really wouldn't by noticed by most users. The only place where MSE seems to fall down is on hard disk scans. There I have seen reports of initial complete scanning taking 8 – 24 hours! I have done both a Quick Scan and a Full scan of my hard drive, about 50 GB of data on a 140 GB partition. The Quick Scan was done in less than 2 minutes. The full scan took about 25 minutes. So from my perspective, on my system, the scanning time is not excessive. I have used other malware checkers that have taken over an hour to accomplish a complete scan on the same drive.

If you want to install this application, the first step is to download MSE from Microsoft's web site (http://www.microsoft.com/security_essentials/?mkt=en-us). This page has the download link for the msi file which can be


of "Save". If you have questions about the installation Microsoft has a video showing all the steps involved. Once the installation is complete the opening screen shows the current status of your protection and the date of the last update for the malware definitions. It also shows you the settings related to scanning your hard drive. From this page you can do a manual scan of your drive. The Update tab on the top of the page takes you to a page where you can manually update the malware definitions. MSE will automatically download updates when you are running Windows and are connected to the Internet. However, it may not occur immediately on connection. So if it has been some time since you connected to the Internet you may want to manually download the definitions.

The settings page, shown in the next figure, is one where you can mostly accept the default values. One you will probably want to change is the timing of the automatic scan. MSE defaults to midnight on one day, Sunday I think. You will probably want to change this to a time when you know that your computer will be turned on.

The list on the left of the window shows the additional settings categories for MSE. The "default actions" relate to what should be done with any malware detected. The various categories of default actions run from low threat to severe. In all cases I have set mine to remove the malware. If in doubt as to the effect on your computer you can set the lower threat levels to be quarantined. If you wish to later remove a quarantined item, you can do so from the history page. Select "Quarantined items" and you will then be allowed to remove all or individual items. You can also select to restore an item, but this is not likely to be a good idea. Read the description of the what the malware's actions are carefully before deciding to restore it.

This next figure shows you the protection being provided by MSE. In most cases it is best to leave the default settings so you will get the best protection. You will note the category for behavior monitoring. This allows MSE scan for possible malware that is not in its definitions list. This is referred to as the "heuristic" programming of the software. Any application that seems to be altering the functioning of the operating system, such as a rootkit, should be flagged by this function. This is the

only way that any anti-malware application can attempt to stay ahead of the malware writers who are always coming up with new, more complex schemes for infiltrating your computer.



I hope you can see from this quick review of MSE, that it is designed to provide a simple user interface for a complete protection package. Now more tech-savvy computer users might want more control over their anti-malware protection, but for most users, I think this is a good fit and the price is right.

As I mentioned earlier, I have been running MSE under Windows 7. This is Microsoft's best operating system yet. I think this is demonstrated by the fact that the Win7 SP-1 has no really significant changes to the basic OS. Also, Win7 does seem to be more secure than earlier versions. So if you are still running Vista or WinXP, in my opinion, you should be seriously considering a change to Win7. At the very least, whatever OS you are running, be sure to practice "safe computing".

Registry First Aid

Solving the Registry Cleaning Dilemma

Nothing much happens in Windows without control by that mysterious architecture known as the Registry. It is a humongous database repository of instructions, commands and framework for the software, hardware and just about every other kind of ware that functions in Windows. You can also think of it as the Windows brain, and fooling with it is about as welcome as brain surgery self-taught.

Unfortunately and as unwelcome as it may be, the Registry does require some basic manipulation by users from time to time. Add or remove software or change the locations of its components, make routine changes in Windows, and a whole host of other functions in everyday computer usage result in changes in the Registry. In time it can easily become bogged down with errors that can dramatically hinder the normal or optimal functioning of your computer. It's little wonder why keeping the registry clean and error free is so important, yet so avoided. It's even less wonder why the average computer user either shuns necessary Registry housekeeping altogether or winds up employing tools that do considerably more harm than good.

A clean, error-free Registry is vital in keeping your computer working properly, but finding and fixing Registry errors indeed poses a dilemma. There is no shortage of utilities that promise to make your computer function like new by taking out your Registry garbage. Unfortunately, you are most often better off living with an error-laden Registry than one whose key functions have been impaired by incompetent fixers.

With all these caveats in mind, I spent considerable effort, investigation and experimentation years ago to find the Registry cleaning utility that would do an honest, safe and effective job. Through several versions of Windows and most recently with Windows 7, I have been using Registry First Aid (RFA). It is a well-known, popular, easy to use and remarkably competent Registry utility that will find, fix, and prevent Registry errors and malfunctions safely and effectively. It is the only one I trust to do the job! Here's what it will do:

1. RFA will search the Registry for errors. Your first search will undoubtedly come up with an amazing number of errors. It will present a color coded list of them. *Those in green can be safely eliminated or fixed.* For each error, you will be provided with a reason for its problem and an indication of what is needed to either delete or fix it. If, for example, a software reference is not valid because it is sitting in the wrong place, RFA will discover where it rightfully belongs and offers to put it there. If no fix is possible, it offers to delete it.

Those errors that require caution in fixing are listed in yellow, along with reasons and recommendations. The choice will be yours. Those listed in red are also explained and high caution warned.

In any event, each and every error will be explained, recommendation made, and the choice for action will be up to you. No changes are automatic. You are in complete control!

- 2. Registry backup and restore. Before making any changes, you might want to back up your current Registry configuration. RFA stores the backup and you can at any later time restore the Registry to exactly the way it was before you modified it. Great safety feature!
- 3. Registry search. If you need to find anything in the Registry, RFA will do a lightning fast keyword search for you. A great feature in finding and eliminating references to software you have gotten rid of.
- 4. Registry management. Set up the Registry in your own parameters to function according to your preferences.
- 5. Defragment and compress the Registry.

May 1, 2011 Main Meeting Report

Jim stated that he will be on the ballot for President for this coming year, but not after that.

Elections for all elected positions on the Executive Board of the NOCCC will be held at the June meeting. There is an article about the positions on the Executive Board on page 4 in this issue. Nominations will be accepted at the June meeting.

Main Meeting Topic

Our speaker was Michael R. Riley, who gave us a presentation about preventing planned obsolescence in computer hardware and his fix for these problems. He said he has been repairing computers since 1987, but has a wide set of experience at other

fields as well. He started by asking us who had bought PCs that used DOS, PCs that used various versions of Microsoft Windows and whether they had problems and whether they still worked. His premise is that computers can last a long time, but they don't because they have problems intentionally designed into them; planned obsolescence.

He mentioned that there are several simple things you can do to fix a computer. The easiest fix is to clean the connections, which removes surface oxidation. This works for connectors and jumpers as well.

Michael claims to have discovered a relatively simple process in 1996 that allows him to fix circuit boards that other repair professionals have not been able to fix. He says he can fix motherboards, boards in printers, printer power supplies, floppy drives, CD-ROM drives, hard drives, and others. However, most important is that he says these problems were designed into the systems.

According to Michael, the essence of the problem is that there are there are non-detectable viruses or malicious code that can exploit planned obsolescence in computers and cause them to break down every three months. Symptoms can include a lock-up of your computer, the disappearance of files and many other things. Reformatting your hard drive would get rid of the problems for about three months, but they would always return.

He had a list of Internet addresses that he pasted into an Internet browser one after another. Each site was a website that described a computer problems or conspiracies. For example, he described a floppy controller defect, which may have been present in Toshiba notebook PCs. Under certain circumstances, corrupt data would be written to the floppy and/or hard drives. Apparently, Toshiba and NEC Electronics were sued by the State of Texas and settled for \$2.1 billion in a 1999 out-of-court settlement.

Michael also described incidents of cybercrime, which he believes to be a serious problem. He was referring to the hijacking of email accounts, networks stealing your information, identity theft and denial-of-service attacks. For example, in 2009, the World Bank announced it found spyware on its computers which had been there for more than one year. In April 2010, China Telecom reportedly rerouted more than 15% of the world's Internet routes through China for 18 minutes. This possibly allowed them to intercept email and other Internet traffic. The recent incident in which the Sony Playstation network was compromised may have affected 77 million people! Similarly, even Congress is concerned about tracking people using their Smartphones.

The question is whether all of this hardware, most of which is made in China, could have a hardware back door which could allow unwanted access to our computers. It has been reported that Diebold voting machines can be hacked as well.

Michael says he discovered this problem and his solution after he obtained a version of DOS he believed to be a legal copy of MS-DOS. After upgrading DOS once, he installed Windows 3.1.

Five years after installing Windows 3.1, he realized he was distributing an undetectable virus to his customers via floppy disks. This may be some assembly language malicious code, so it may not be a computer virus in the usual sense. The virus wasn't removed by anti-virus software or by a command sequence provided to him by McAfee. He suspects that it may have been the result of mixing Windows 3.1 and an apparently illegal copy of DOS.

He says that his process resolves 70 to 80% of the problems that are not caused by abuse, power surges, bad power protection and similar gross problems. (Reporter's note: The capacitors on my six-year-old Pentium III motherboard that started leaking are probably an example of one of the things he can't fix.)

People thought their PCs were lemons because they locked up and acted weird. Printing a 30-page document would result in the first ten pages being printed and the rest would print 2 hours later. People bought new computers when they thought the old ones were bad.

Michael said his fix "blows me away." It allows him to fix things everyone else can't, such as motherboards that won't POST or detect hard drives. His process gets rid of incompatibilities between Microsoft software and non-Microsoft software. He showed us some testimonial letters in which his customers, other repair professionals, described about his repairs after they had given up.

The fix is a combination of hardware manipulation and software manipulation. If you combine his process with the sequence of commands he got from McAfee, which was supposed to get rid of all viruses, you can get rid of the non-detectable virus and improve the performance of the PC. He said anyone can be taught to do this process. The hard part is getting the motherboard out and putting it back into the computer. He also told us that there is no soldering, or removal or replacement of components on the boards.

Michael says he has developed this process into a way to keep a computer working much longer than the normal service lifetime. He wants to give a seminar to a group of people. He estimates that knowing this information will easily save you \$1,000 over a lifetime. He set the cost of the seminar at \$200, but said it was negotiable.

However, while all this was interesting, what was not mentioned was how long the seminar is and does it cover more than just Michael's process? His examples and testimonials seem to start with DOS computers and end with Pentium 4 vintage computers. So, how applicable is his "really big fix" for modern computers? Windows 95 swallowed up DOS as you may recall.

Cell Phone Lingo

When it's time to buy or upgrade to a new cell phone, are you as confused as I am with all the fancy terms and acronyms in the sales pitch? They make my head spin. Some of the terms you will encounter refer to the technology generation of the phone, as in G0 to G5. About every 10 years the next larger G (generation) number appears denoting a major improvement in cell phone technology. Each generation improves the speed, security, power usage, range and reliability of cell phones.

G0 refers to the original mobile telephone, a large unit stored in the car trunk with a hand-set between the driver and passenger seat. Remember those? Essentially it was a souped-up shortwave radio. These first made the scene via Motorola and Bell Telephone in the 50's.

Next came G1 using GMS tech (see below) which also was analog, first introduced in Japan in 1979 and later in the USA in

1983. In 1992, G2 was a major improvement using digital technology vs. analog that was used in G1. So what's the difference? Analog is a continuous smooth signal like whistling a tune. Digital rapidly samples the song and converts each small time segment into a series of ones and zeros, or digits. Through some clever complex calculations, these digits are converted back to the original sound tone and volume. The advantages of digital are that the data can be compressed and encoded for security and no information is lost as long as the I/O signal can be detected, even from a lot of accompanying noise.

In 2001, 3G was introduced using a new technology called CDMA (code division multiple access) developed by our local Qualcomm company. This is a very complex encoding that allows many more users on the same channel at the same time. G3 is probably the most common system in use today.

G4 arrived in 2006 and allows 1 Gbt/s (one gigabit per second) downloads from a fixed location or 100 mbt/s (megabits per second) from a moving vehicle. These high speeds allow streaming high-definition video (HD movies) on your cell phone. Also, connections to the Internet are faster and better. G5 is still in the lab and promises even more features, but may not arrive before 2020.

The cell phone field is rampant with 3, 4, and 5 letter acronyms. Here are a few that a salesman may try to impress you with:

GMS (global mobile system): still widely used in older phones.

TDMA (time domain multiple access): sharing the airwave in small time slots.

FDMA (frequency domain multiple access): sharing the airwave in different frequencies.

CDMA (see above).


An analogy to the problem of multiple access is a room (channel) in which people wish to talk to each other simultaneously. To avoid confusion, people could take turns speaking (time division), speak at different pitches (frequency division), or speak in different languages (code division). Other terms you may encounter are LTE (long term evolution), OTDMA (orthogonal TDMA) and WiMax (similar to WiFi). These are fancy names for some of the latest improvements in the field. So the best strategy for buying a new cell phone is to read the reviews and then find a salesman you can trust. Some of the above information may help you understand his pitch and also impress him with your knowledge.





Member Has Problems with Focusing His Camera

Trying to take photos of the animals at the zoo the camera kept focusing on the fence and not the animals. How can he get the animals in sharp focus?

I could only explain a process to fix this problem in general terms because all cameras work differently.

- 1. One method is to put the camera in manual focus and set the distance as best as you can.
- 2. Another method is to extend your lens to maximum telephoto. If you can then focus through the fence or barrier then hold the shutter halfway, which will lock the focus on most cameras, and adjust your lens to the focal length for the photo and press the shutter all the way.

To get an even better picture you might also use a very large aperture. This will allow you to focus on the animals and the fence might be a fuzzy blur. If your camera has aperture priority, then set your aperture wide open. The smaller the aperture number, the larger the opening. Combine a large aperture with the focusing method described above and you just might get a nice photo.

Lightroom 3

I just purchased Adobe Lightroom 3 and I went over some of the features of this image organizer program. We will not be doing this anymore. Lightroom 3 is an advanced program better discussed in a separate SIG.

I did talk about how I have reduced my use of 3 other programs: Picasa, Adobe Elements, and Nikon's PictureProject. Now I only use Picasa for organizing and uploading the pictures I take at the NOCCC meeting. I rarely use Adobe Elements and I no longer need to use Nikon's PictureProject.

PictureProject was the program I used to transfer my images from the camera to the computer. Nikon's PictureProject has been completely removed from the computer.

Not only have I reduced my use of other programs, but Lightroom has made it much easier and quicker to create save image files I need for my blogs and web site.




Advanced Digital Photography

Last Month

The May meeting was about using polarized light to reduce reflections from plastic packaging when photographing objects like dolls. Many people take photos like this to sell items on E-Bay etc. In the past, we have examined reducing reflections from glass; but the more irregular surfaces of the plastic pose additional problems. Using polarizing filters on the light source as well as on the camera can reduce the reflections more than polarizers on the camera alone.



The polarizer on the light source need not be of high optical quality, it is only necessary for it to polarize the light. (I have actually gotten good results with a lens from a pair of Polaroid sunglasses that I found in the road after it was run over by a car.) Most of us already posses a very high quality polarized light source, in the form of an LCD monitor. Simply having a white (or any other color for special effects) image completely fill the screen makes an excellent source of polarized light that can increase the efficiency of the polarizer on the camera. For some macro shots, you can even use the screen on the back of an old digital camera as the light source.

To take this shot of a CD in its clear plastic case, I used an old Pentax Optio S40 pocket sized point & shoot to take a picture of a white piece of paper. This image was displayed on the Pentax's 1.5" LCD provide polarized light source; which was the sole source of light for this picture. The CD & its case were placed on the back of the camera. An Olympus E-10 digital camera with



a polarizing filter on its lens was then used to take the picture shown here. All of the colors are the result of the polarizers and the way plastic (and many other transparent materials) affects the polarized light. In this case, the colors were created by stress patterns in the plastic. Where the plastic was thick enough to refocus the Olympus camera, you can even make out some of the dots on the Pentax's LCD.

We didn't have time to complete the live experiments with the monitor as a light source since we digressed for a fair amount of time on a discussion of a ViewSonic VP2365wb monitor and its special features that make it so good for editing photographs.

To take this shot of a spirit level, I placed a strobe light on a table with its plastic diffuser pointing up into the air. I placed a polarizing filter on top of the diffuser and then placed the level of top the polarizing filter. Finally, I aimed a camera with a second polarizing filter down at the level and took the shot (the strobe light was triggered remotely by camera). The green color is mostly from the fluid in the level's ampoules. The blues



and oranges are from the polarized light. The skyscraper window-like pattern is the grid in the strobe light's diffuser.

We will revisit the topic of photography using polarized light at a future meeting.

At the June meeting

There are times when you just can't get as much depth of field as you want. This can be because low light and/or a high shutter speed require you to use a very large aperture. It can also happen with telephoto shots that just naturally have a shallow depth of field. Worst of all are macro shots that have a ridiculously shallow depth of field.

We will examine how to take several shots with different focus points and combine them into a single image with a much greater depth of field. This is known as focus stacking. Focus stacking is a useful trick to have in your bag. Come see how it's done.

Microsoft Access

PC Q&A

I spent some time this month on both Firefox 4 and video cards. As most of you probably know, the final version of Firefox 4 was recently released. There are a number of new features in the program, and things have been rearranged a bit. Depending upon which operating system you are using, the default installation looks a little bit



different between Windows 7 and XP. One significant change to Firefox and other browsers is the implementation of HTML 5. This is an under the hood kind of change, you don't see it, but it is there and it affects what the browser can do significantly. What is HTML 5? There is no way that I am going to try and explain everything about it, in large part, because I don't know that much about it. One of the descriptions that I read about it, said simply visualize that it can replace Adobe flash, and you will have a better understanding of what it can do. Whether you know it or not, you have probably seen one of the Adobe flash animations that is in fact a form of video.

One of the computers that I own is an older model of the Shuttle XPC small enclosure computers. This particular one is based on an AMD single core Athlon XP 2800+ CPU, one gig of PC 3200 RAM, and video integrated into the motherboard. My main desktop computer is an E8500 dual core CPU with four gig of DDR 2 RAM, and a HD 5770 PCIe bus video card with 1 GB of RAM. The Firefox 4 update was installed on the desktop first and the Shuttle second. When you first start up the Firefox 4 installation, it brings up a screen that has a couple of choices to click on. One is labeled "Step one, Meet Firefox 4." When you click on that choice, it brings up a screen to show a one minute long video, more accurately a one minute animated video. You can see what it looks like on your machine by going to: http://www.mozilla.com/en-US/firefox/4.0.1/whatsnew/

When that video played on the desktop, it looked like the smooth movie that it was supposed to. When it was played on the Shuttle with the screen resolution set to 1024 x 768 however, the sound was good, the background was solid, but the objects that were moving on the screen were not smooth. It is tempting to describe the video as jerky, but more accurately, the objects that were moving on the screen were disjointed. As an example, towards the end of the one minute video, a larger version of the Firefox logo is placed in the middle of the screen. You are supposed to see a small rocket ship enter the screen from the top right edge, fly behind the logo, arc around in front of and below the logo and exit the screen. Instead, I saw one image of the rocket flash into existence in the position of in front of and below the logo, and then it disappeared. Clearly, something wasn't working right. I brought up TaskManager and set it to the performance tab. When I played it again, I saw that the CPU was pegged at 100% occupied.

I wondered what it would do if I was to put a real AGP bus video card into the machine instead of the onboard video. The

first video card that I happen to find was an older NVIDIA TNT2 card with 64 MB of display RAM. I installed the card, installed the latest driver, and tried it again. The display was slightly less disjointed, but not by very much, and the CPU was still pegged at 100%. I looked for a somewhat newer and better AGP video card and found an ATI Radeon 8500, also with 64 meg of display RAM. I installed the rather large driver and ran the test with similar results. More frames of various objects that were moving on the screen were displayed, but still significantly disjointed, and although the CPU usage graph did go down to 88% periodically, it mostly stayed at 100%.

I've then tried an even newer card, a NVIDIA FX 5500 with 128 MB of display RAM. Again, I saw more frames of the objects that were moving on the screen and the movement was somewhat less disjointed, but certainly still there, and the CPU usage in this case was again a solid 100%. This is the newest and most powerful AGP card that I have, so I was not able to see what a better card would do. I would expect a better card to have an even smoother display, and perhaps even not run the CPU at 100% usage, but I don't have the hardware to prove it. On the desktop, the video is completely smooth, and CPU usage seldom gets above 8%. Of course, the ATI Radeon HD 5770 is a fairly high-end video card and the CPU is far more powerful.

What's the point of saying all this? Well, for quite a long time, when someone asked whether or not they should upgrade their video card, I said it depends upon what you're doing. If you're not doing heavy-duty video editing or playing some of the highend games, there's probably no real point in doing an upgrade. Now, however, a number of things that you will encounter when surfing the web are going to have either high-end Adobe flash animations or HTML 5 animations. As I commented above, if you do not have good enough hardware, the videos that you watch will not look very good. Without a lot more testing, I'm not sure where the sweet spot is located in terms of how powerful of a video card you should purchase. I do know that the 5770 is a very capable card that meets all of the latest specifications for directX-11 and other video attributes. I do know that the recent price drop means it is selling for about \$100 less than I paid for my card six months ago, or around \$130 at the moment. That may still seem like a fair amount of money, but on the other hand, you're getting a very good video card. Till next month.

Railroad

Meeting Information — The NOCCC meeting is held at Chapman University, in the Hashinger Science Center and Irvine Hall, near the northwest corner of N. Center St. and E. Palm Ave.

Parking Information - Chapman University's main parking lot is the underground Lastinger Parking Structure under Wilson field on the north side of the campus. Enter from Walnut Avenue, just east of Glassell Street. Parking is not free on Sunday, even if the gate is up. However, the permit vending machine is about 100 feet south of the entry area. There are other machines elsewhere in the lot. Find one, buy a permit, and put it on your dashboard. Do not park in any other lot, in a reserved space, or back into a space.

Free street parking also is available on the campus-side of the streets only. Parking in front of any residential housing will result in an expensive parking ticket. A City of Orange public parking lot, located on the southwest corner of E. Maple and N. Orange, is also free and only 2 blocks from the meeting.
