

Board Meeting Minutes Approved August 7, 2016

The meeting was held in room 131A at Chapman University Science Hall. The meeting was called to order by President Ben Lochtenbergh at 3:30 PM. Present were: Ben Lochtenbergh, Bob Dickson, Terry Dick-



son, Larry Klees, Dennis Martin, and Gerry Resch. Absent were: Don Armstrong, Jim Sanders, and Richard Miller.

Secretary's report: Bob distributed copies of the minutes for the 7/10/2016 meeting. Gerry moved to approve, Dennis 2^{nd} , approved.

President's report: Ben reported that Richard was unable to attend the meeting today due to health problems, Don was on a trip, and Jim had some personal business to attend to. Ben announced the pizza and drinks on the side table were paid for last month but weren't ordered in time so the board will have pizza and drinks at this meeting.

Treasurer's report: Due to Don's absence, no figures were presented regarding the bank balances.

Bob reported a member paid for 1 year dues in cash (\$35.00). He reported the member paid in cash because his check either wasn't deposited or was lost and his copy of the Bytes had the notation about being the last copy. Bob gave the member's name to Ben. Ben will update the database showing the dues have been paid.

Bob reported that the donuts and cookies cost \$24.98 and income for them was \$22.50.

Bob reported that two cell phones donated by the eWaste company were purchased by a member for \$5.00 each. Since the cell phones were donated to the club, the full \$10.00 will remain with the club, no payment to the donor.

Ben reported that the payment for the club's insurance is due in September. He noted that the investigation he's done for a possible new insurance provider has not revealed anyone with a better offer or at a better price, so he will contact the current insurance company to renew the club's insurance for the coming year at the cost of \$98.00 per month. Ben said he would also check if the insurance provides coverage for all of the directors. It was suggested that Ben check to see if a single annual payment would be less than the 12 monthly payments. There was general discussion regarding the annual payment. Dennis moved to stay with the same insurance company and to make a single annual payment rather than the 12 monthly payments. Gerry 2nd the motion. All voted to approve the motion.

BYTES report: Bob noted that he received the 6 extra copies which he placed on the entrance table

for new members or guests to pick up. He received his copy and the 6 extra copies several days before the meeting.

Raffle report: Gerry thanked Bob for the donated raffle prizes so the prizes for this month were at no cost to the club. The raffle income for tickets was \$26.00. Gerry reported only 5 people purchased tickets but there were others who presented parking passes to get tickets.

eWaste report: Bob noted he provided several items to the ewaste people. He noted they had received several old computers and other items so it was a good month for them.

Consignment table: Due to Richard's absence, Bob cancelled his SIG session in room 127 and moved his computer to the main hall entrance to provide coverage for the consignment table and to provide reception info to any visitors. Bob noted there were a few items on the table. The ewaste people donated a laptop and 2 cell phones. Other items were placed on the table. The 2 cell phones were sold for \$5.00 each. The suggested price for the laptop was \$140.00. It was not purchased. It was locked in the cabinet to be used at a later meeting. The other items on the table not purchased were taken back by the person who had placed them there.

Main Meeting report: Mark Hammon continued the presentation on DNA and the computer that he'd started at the July meeting. His presentation was informative and much appreciated. Ben expressed his appreciation for Mark's support of the club.

Ben noted that for the September meeting presentations will be by each of the 3 scholarship recipients. For the October meeting, Larry will make a presentation on digital photography. The November and December presentations have not been determined yet.

Ben commented that he might try to get the Microsoft guy to come back and maybe do some more presentation on Windows 10. Many people are still trying to get comfortable using it.

Due to Tom and his wife being on a trip, Bob came in early and set up the tables and prepared the coffee and tea. Bob noted the difficulty working with the locks on the cabinets in the storage 4 \square NOCCC Orange Bytes \square Septembert 2016

room. They are difficult to get to open. He was fortunately able to get them to open but they need to be looked at.

Members' badges: Gerry reported that he'd called some of the members who apparently were waiting to get a badge. He reported that many of them either had an old badge or had let the membership lapse. This month's Sig meeting addressed Wi-Fi Calling, (CNET)

Wi-Fi calling is nothing new; apps like Skype, Google Hangouts, Facebook, Messenger and WhatsApp make it easier to use a phone to place calls and send texts over the internet and do without mobile networks altogether. Carriers are also adopting Wi-Fi calling themselves. Whether it's because they want to bolster their network coverage or improve user experience, several networks have phones that have this service built in to help you make sense of what Wi-Fi calling is, why it's important and what you can use it for, CNET put together a handy guide to walk you through everything you need to know.

Wi-Fi Calling is a service for Android and IOS smartphones providing the ability to make and receive phone calls over a Wi-Fi connection. It's simple to use with no separate application or log-in required. Wi-Fi calling is a free service when calling to a US, US Virgin Islands, or Puerto Rico number. International rates still apply for international numbers.

VoIP, Voice Over Internet Protocol, enables you to make and receive calls through your internet connection as opposed to a **traditional phone carrier**. For many this is a cost-effective and highly efficient solution. However some choose to use VoIP to supplement their phone service as some VoIP providers don't offer common phone services like emergency calls and phone directory listings.

What is an IP phone? An IP phone, also known as a VoIP phone, is a phone which relies on internet technology to make and receive calls. With VoIP phones, voice calls are converted into data and transferred in a similar way to email. The useful thing about these phones is that they can be used to call landlines, mobile phones and can even be used for computer-to-computer calls.

Voice over IP (VoIP) Linux software enables telephone-like voice conversations across IP based networks. A VoIP phone service is often cheaper than a traditional Public Switched Telephone Network (PSTN) phone service and removes geographic restrictions to telephone numbers.

SIP is the most popular VoIP protocol. This protocol enables two or more people to make phone calls to each other using the Internet to carry the call. SIP to SIP calls on a broadband internet connection are high quality, always free regardless of distance, and offer additional functionality such as free voicemail to email and phone numbers, caller ID, 3-way conference, speed dialing, call forwarding, simultaneous ring, call waiting, call return, caller ID block, and anonymous call rejection.

Mobile Computing

Oh boy do I have some stories to tell the next SIG meeting! I decided to go on vacation without a PC, just do all of my work with my SAMSUNG smartphone having only carry-on luggage.

Well that worked until I debarked from a water-taxi onto the little island of Bonaire. I had to swim ashore because there is no pier and the island has no building. Truly an uninhabited island. You must have guessed it, my phone, not so smart of me, **got wet and failed**. I couldn't use Google Maps to see where we were which led me in to even more trouble. Bottom line I bought a cheap BLÜ smartphone for \$128 in Curacao when my Samsung phone didn't fix itself when it was dry.

I will talk this September 11 meeting about setting up a new Android 4.4.1 phone, its limitations, the difficulties of restoring apps and communications. We'll look at ways by which this unthinkable problem can be minimized with better planning.

As to what happened last meeting, I think I spent too much time on Pokémon. One member left, I think disgusted with this topic. The next day I uninstalled it from my phone! See previous Orange Bytes about my trepidations.

One nice thing about the new BLÜ phone is that it has two SIM card slots. I bought a 10-day SIM card with TELCEL for Mexico calls and data and used the SIM card from AT&T out of my wet phone for roaming from the USA. I'll show a new app called SIM management native to the BLÜ phone and some screenshot to show past history.

Advanced Digital Photography SIG

At the August meeting we were treated to view some wonderful large prints framed for wall hanging by one of our members. In a random



access fashion, we discussed photographic prints on aluminum, the disadvantages of overly shiny computer screens for photo editing and a wide variety of other topics. I steered away from a couple of topics which I felt would be better saved for the October main meeting (More about that in the next issue of the Orange Bytes).

In addition to Photoshop, I have been using a photo editing program called DXO OpticsPro 11. We have discussed some of its features in the past; but five of my favorite features are amazing and I want to discuss those in more detail. They are DXO SmartLighting, DXO Clear View, Micro Contrast, Noise reduction – RAW, and perspective adjustment with the rectangle tool.

Of the two nearly identical images below, the first was processed in DXO OpticsPro in about five minutes and looks beautiful except for being slightly out of focus. The following morning (under nearly identical conditions), I reshot the same subject using focus stacking and processed that one in PhotoShop. That took about an hour to process — about forty minutes for the focus stacking and about 20 minutes to duplicate the work that only took five minutes in DXO OpticsPro. I believe the DXO version is better. At the meeting we will take an un-edited focus stacked version from Photoshop and edit it in OpticsPro to make a single good photo.


