Board Meeting Minutes January 8, 2017

Secretary's report by Bob Dickson

The meeting was held in room 131A at Chapman University Science Hall. The meeting was called to

order by President Ben Lochtenbergh at 3:10 P.M. Present were: Ben Lochtenbergh, Don Armstrong, Bob Dickson, Terry Dickson, Larry Klees, Dennis Martin, and Gerry Resch. Absent were: Richard Miller and Jim Sanders.

Secretary's report: Bob distributed copies of the minutes for the 12/04/2016 meeting. Gerry requested deletion of a comment regarding receiving copies of the Orange Bytes: "~~Gerry receives 1 extra copy to give away.~~" Dennis requested correction of a Main Meeting statement: "Dennis stated that ..." be corrected to: "Ben stated that ..." Gerry moved to accept the minutes with the corrections, Terry 2nd, approved.



President's report: Ben noted that he'd received a call on Saturday that the planned speaker for the Sunday meeting was sick and would not be able to make the planned presentation. Since Jim was out sick Ben stepped up to make a presentation.

Treasurer's report: Don presented figures for the current month and the meeting.

Ben had prepared an Excel report for the club finances for 2015 and had given it to Don. Ben asked if Don had time to work with the report and update the figures for 2016. Don has been reporting expenses and revenue at the monthly meetings. Don stated his figures are very similar to Ben's figures for 2015. Don noted that the cost of insurance was reduced by paying it annually rather than monthly. Don noted the investment account will mature in early February. The funds will be placed in the checking account by the bank. There won't be any interest paid while in the checking account. Don noted the funds will not remain in that account for long. Don will work with the bank to maintain liquidity to be able to pay expenses as they come due. He'll check with the bank. Gerry moved to accept the treasurer's report; Larry 2nd; approved.

Bytes report: Gerry commented that he hasn't been receiving any copies of the Bytes, possibility because he hasn't paid his dues. Ben commented that he and Gerry need to get together to get the situation cleared up. Bob noted that the date on the January Bytes was 'January 2016'. Ben apologized for the error (it

should have been 2017). General discussion about having Ben and Don keeping their separate copies of the database and the need to keep the data current in both. There are still members complaining they're still not receiving their copies of the Bytes. Don stated that he updates the addresses when a person renews and then sends the data to Ben. Ben commented that he needs to receive any data at least 2 weeks before the meeting so he has time to send the file to the printer in Florida.

eWaste report: Bob asked Gerry if the operator for eWaste will be at the February meeting. Gerry called and received a positive response that the ewaste operator will be at the February meeting. Ben will have an announcement on the front cover of the Bytes.

Consignment table report: Due to Richard not being at the meeting, Bob cancelled his SIG meeting site and remained at the main entrance area in case anyone had some question upon entering the hall.

There was considerable discussion about ensuring that SIG attendees would have an opportunity to purchase items on the consignment table. The Board had decided that for items of high value that the item should not be sold until attendees at the SIG sessions have an opportunity to bid on the item. After lengthy discussion Ben instructed Bob to prepare rules to handle the sales of consignment items that might have considerable appeal by not closing the sale of the item until SIG attendees would have a chance to bid on it. Bob will prepare prospective procedures and submit them to the board for review before the next meeting.

Bob noted that there were several items from the December meeting that had been donated to the club by the ewaste operator that were locked in the cabinets in the store room. They will be placed on the table at the February meeting.

Main Meeting report: The scheduled speaker called in sick on Saturday 1/7/2017 and stated he could not attend the meeting on Sunday, 1/8/2017. Since Jim was not at the meeting on 1/8/2017, Ben stepped up to make a presentation on the transmission of sounds using Bluetooth and Wi-Fi between a computer and a smart phone. He also demonstrated using a small flash drive-type device that contained recorded sounds of the transmission

between the device and the computer and then out to the phone or another sound device. Bob noted he found the presentation impressive and educational. Ben had to respond to many questions from several persons in the audience indicating interest in Ben's presentation of the equipment and procedure.

The February speaker will be Bob Cohen of Bobology.com. He teaches at Santiago College.

The March speaker will be about the Avast Security System.

The April speaker will be Billy Chang of Microprinting.com who will demonstrate 3D printing.

Member Badges report: Gerry found his equipment and is ready to prepare badges. He said he needs a club logo in digital format. Ben will email to Gerry a logo in a PDF file. Gerry will produce the badges.

Web Site report: no report due to absence of Jim.

Adjourn: Gerry moved to adjourn the meeting. Larry 2nd. Approved. Ben declared the meeting ended at 4:25 PM.

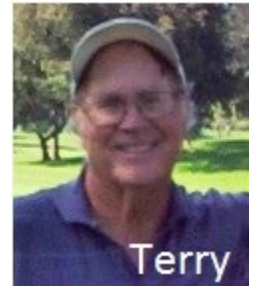

This month's Sig meeting was about the small MIS Wind Box Computer. This PC comes with an Intel Celeron 1037U-1.8 GHz processor. 500GB Hard Drive. 4GB of ram...



The Wind Box DC111 has elegant lines and a slim, lightweight chassis. It is just 7.55" X 5.94" X 1.37" in size, and weighs under 2 lbs. The DC111's unique ID design makes it easy to store and move around; this ultra-mini PC is perfect for both home and office use.

Tests have confirmed that, in regular operation, the Wind Top DC111 maintains average power consumption that does not exceed 40W, less than half that of most conventional PCs. I bought this unit without any operating system for less than \$150.00 Dollars, because I wanted to install Linux Ubuntu (Kylin) 16.04.2 LTS for display at our Linux Class.

Due to the size of the unit I can move it around without any problem. The Unit comes with two (2) USB 3.1 ports in the back a HDMI output, a VGA output LAN- JACK auto output and S/PDIF... the front has 4 USB 2.0 ports head phone jack MIC jack Wi-Fi LED and also has a 3-in-1 (SD / MS/ MMC) card reader slot. The unit is very quiet. We should have fun playing with this unit.

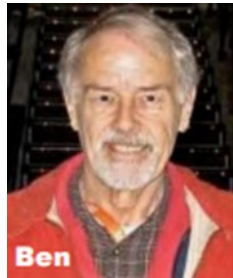

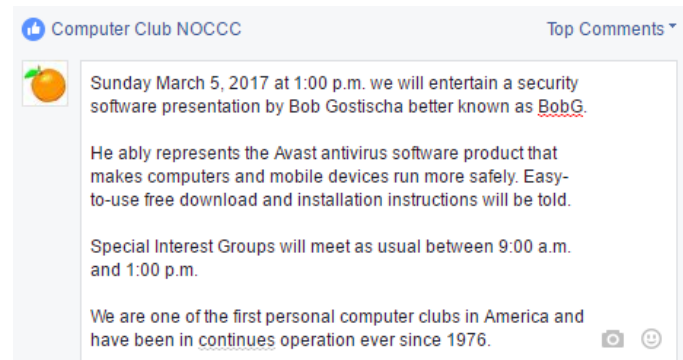
